# **Integrated Care Strategy: Start Well**

#### **Purpose**

Start Well is a key priority within the Integrated Care Strategy. The purpose of this report is to:

- 1.1 Provide an overview of Start Well, what it is, what we are aiming to achieve, why it is important and how it will be measured.
- 1.2 Present our approach.
- 1.3 Present progress to date and barriers / challenges.

- 2.1 To acknowledge the importance of 'getting it right' for children.
- 2.2 To <u>acknowledge</u> other priorities exist in the system.
- 2.3 To <u>support</u> the release of resource through efficiencies in system governance and assurance processes.
- 2.4 To <u>acknowledge</u> pace of delivery is impacted by resource available.

3.1 This is aligned to the Integrated Care Strategy Delivery.









#### **Supporting information**

- 4.1 As previously reported, the Integrated Care Strategy has three areas of focus:
  - **Start Well** To improve outcomes and reduce inequalities in health, social, emotional, and physical development of children in the early years (0-5) via school readiness.
  - **Stay Well** To improve prevention and early intervention of the 3 main clinical causes of ill health and early death in the JUCD population circulatory disease, respiratory disease and cancer.
  - Age/ Die Well To enable older people to live healthy, independent lives at their normal place of residence for as long as possible. Integrated and strength-based services will prioritise health and wellbeing, help people in a crisis to remain at home where possible, and maximize a return to independence following escalations.
- 4.2 The outcome that Start Well is aiming to achieve is that:
  - 'Women have a healthy pregnancy, children are born safe and well into a nurturing and secure relationship with care givers, with good nutrition, access to health care, social care and education. Children thrive and develop positive and healthy relationships'.
  - Delivery of the Start Well outcome is overseen by Joined Up Care Derbyshire's (JUCD) Children and Young People's Delivery Board.
- 4.3 Start Well is focusing on improving school readiness as an outcome indicator of starting well. School readiness is a measure of how prepared a child is to succeed in school; cognitively, socially and emotionally.
- 4.4 Investing in quality early care and education is one of the most cost-effective measures that can be taken, with every £1 invested saving taxpayers up to £13 in future costs (Centre for Research in Early Childhood, 2013).
- 4.5 Early years development is impacted by a range of modifiable factors:
  - Related to the family (maternal mental health, homelessness, family income and parental education)
  - The child (low birth weight, health status and immunisation rates)
  - Services (quality and availability of funded early education) among many others.
- 4.6 A systematic approach will be taken to identify where key improvement opportunities exist to improve school readiness. Delivery will be via Place and will be co-produced with system partners and families.
- 4.7 Successful implementation of the Start Well ambition is dependent on several enabling factors:

- Change management and leadership capacity
- Analytical capacity to understand need, plan, do and review progress
- Local insight i.e., place-based knowledge, networks and influence, includes public, private and Voluntary Community and Social Enterprise (VCSE) sector
- Service improvement and delivery capacity located within relevant organisations and teams.

There are currently capacity gaps across all of these factors which is limiting progress.
