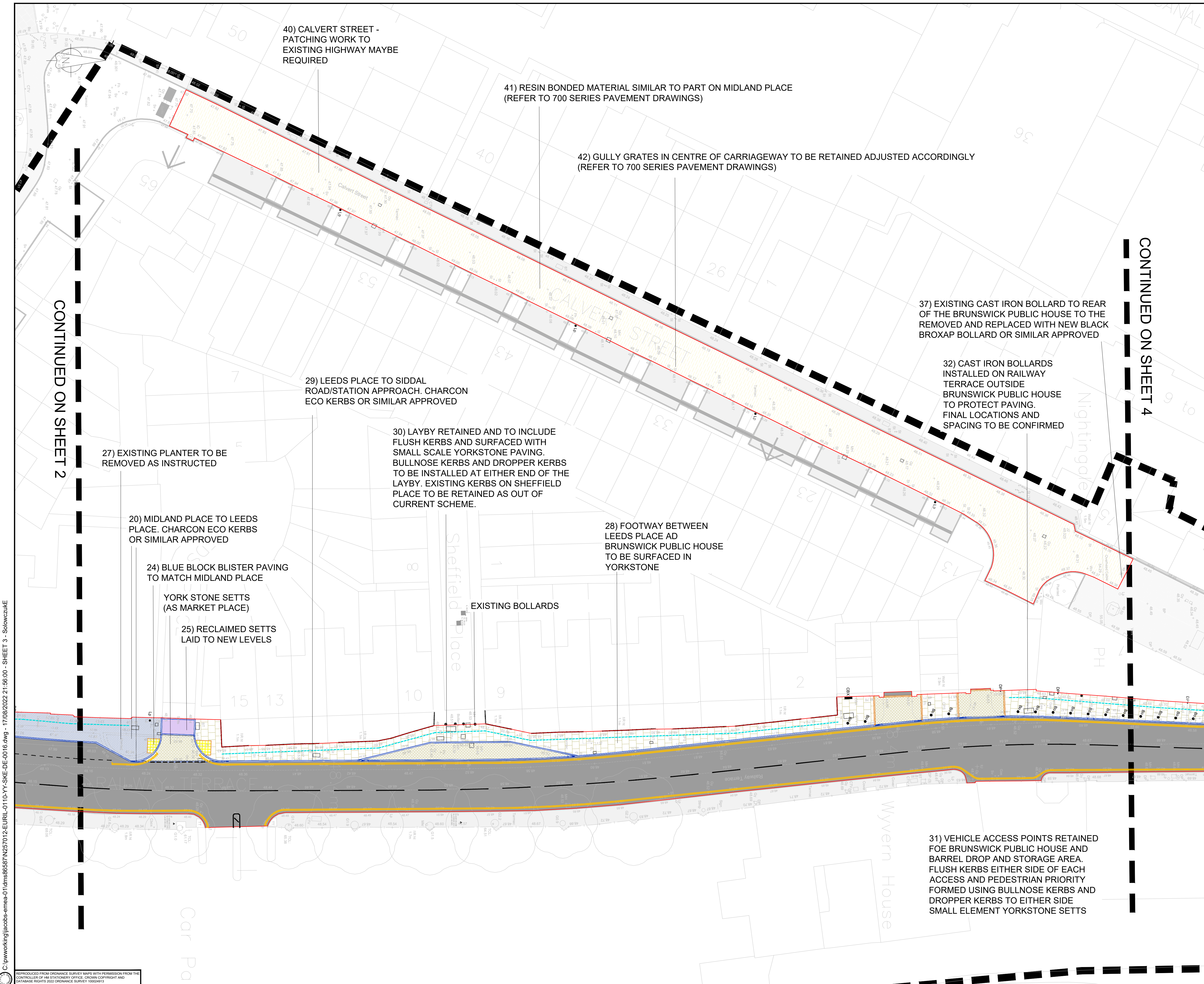

**PAVING / KERBS - EXISTING LIFTED AND LAID TO NEW LEVELS**  
(Detailed photographic survey to be completed by contractor prior to lifting)

- Kelley Staffordshire Blue smooth PAVERS. Some replacement of damaged blocks will be required and laying pattern to match existing. Note some pavers are diamond chequer pattern).
- Yorkstone SETTS. Some replacement of damaged blocks maybe required and paving pattern to match existing.
- Concrete FLAGS. Some replacement of damaged blocks maybe required and paving pattern to match existing.
- Granite SETTS. Selection of sets in best condition from adjacent areas.
- Yorkstone KERBS.

**PAVING - NEW**

- Kelley Staffordshire Blue smooth PAVERS.
- Yorkstone SETTS.
- Yorkstone FLAGS.
- Granite SETTS (square cut to one side).
- Concrete FLAGS Charcon Ecopave or similar approved.
- Concrete BLOCKS Charcon Ecopave or similar approved.
- Resin bound gravel (buff).
- Asphalt.

**KERBS / CHANNELS**

- Yorkstone.
- Granite (Pink). Re use from adjacent areas where possible.
- Concrete Charcon ECO or similar approved.

**HAZARD PAVING**

- Yorkstone (buff) blister.
- Granite (red) blister. Re use from adjacent areas where possible.
- Concrete (red) blister.
- Concrete (buff) blister.

**OTHER**

- Utility cover, infill with adjacent material where possible and set to new levels (subject to further detailed design).
- Traffic signal (subject to further detailed design).
- Bollards at 2.5m spacing (final locations to be confirmed).
- CCTV (Exact positions to be determined on site due to Public House sign. Agreement to be sort with client before erection).
- Indicative surface drainage (subject to further detailed design).
- Existing lamp post / sign post.
- Existing bus stop / traffic signal.
- Existing utilities / utilities covers.
- Existing trees.
- Existing metal railings.
- Conservation boundary.
- Indicative construction boundary.
