01/03 Minutes of Previous Meeting

The minutes of the meeting of the Lifelong Learning and Culture Overview and Scrutiny Commission held on 7 April and 16 April respectively, were noted. It was further noted that Mr John Honey had been present at the meeting on 7 April and his name omitted from the attendance list.

02/03 Grants to Supplementary Language Classes

Andrew Flack, Director of Education, introduced a report setting out the allocation of grants for supplementary language classes funded from the education access service budget. The Commission noted that the changing ethnicity demographic of the city could impact on the distribution of this grant money. Whilst the Minority Ethnic Communities Advisory Committee would be involved in consideration of any redistribution, it was agreed that it was

important to ensure that that Committee's membership was truly representative of minority ethnic communities in the city.

03/03 Grouped Schools PFI Project – Next Stages

Having declared an interest, Councillor Latham withdrew from the meeting during consideration of this item.

Andrew Flack, Director of Education, introduced a report setting out recent progress and future issues in respect of the Grouped Schools PFI Project.

Dave Wilkinson, reiterated the Trade Union's stance of outright opposition to PFI.

The Commission discussed the management arrangements for the project, together with the contractual context.

- 2 to ask the Cabinet Member with responsibility for Education to ensure that re-appointments at a political level to the PFI Board be reviewed as a matter of urgency.

04/03 Review of the Past Year and Suggestions for the Coming Year

The Chair asked Members' views on the operation of the Commission, with a view to improving performance in 2003/2004. Councillor Latham, and others, requested that greater priority be given to evening meetings. However, it was acknowledged that the calendar of meetings was already very full in the evenings not withstanding Members' numerous other commitments. It was agreed that Members should be canvassed on their preference for daytime or evening meetings, and that witness availability was also a factor.

The Commission also considered holding a short pre-meeting for all Commission Members, immediately before each business meeting. This would provide an opportunity for Members to pick out the key issues to concentrate on on the agenda, the aim being to facilitate business more effectively once the meeting was underway. It was agreed to pilot this idea for three meetings with effect from the previous meeting – the pre-meeting would now be held at 6pm with the meeting proper beginning at 6.15pm.

05/03 Remit of the Education Commission

For the benefit of new Members, the Chair recapped the role and status of copted Members and Trade Union observers. The Commission asked that a glossary of education-related terms be provided to all Members.

06/03 Topic Review – School Place Planning

Lynn Senior, Overview and Scrutiny Co-ordinator, updated the Commission on the status of the school place planning topic review. The terms of reference having been agreed in February, it was anticipated that the review would be completed in September 2003, subject to the availability of new Members to complete the review within this timetable. Following the change of membership on the Commission, it was agreed that Councillor Wynn would replace Councillor Jackson on the topic review planning group and Councillor Hird would replace Councillor Les Allen. The next meeting of the planning group would be held at 6pm on 24 June. It was agreed that Simon Longley, Assistant Director of Education, would be invited the repeat the briefing he provided to Members on school place planning, for the new Councillors.

Resolved to agree the changes to the topic review planning group detailed above and to request the Assistant Director of Education to repeat the school place planning briefing for members new to the Commission.
