09/03 Apologies

There were no apologies.

10/03 Late Items Introduced by the Chair

Councillor Skelton introduced a late item concerning an application to renew the Public Entertainments Licence – Diva, Gower Street, Derby. Item 12 minute No 20/03.

11/03 Declarations of Interest

Councillor Brown declared a personal prejudicial interest in Minute No 15/03 as he knew the applicant. Councillor J Hickson declared personal prejudicial interests in Minute Nos 15/03 and 17/03, as she knew the applicants.

12/03 Minutes

The minutes of the meeting held on 10 June 2003 were approved as a correct record and signed by the Chair.

13/03 Application for a provisional Public Entertainments Licence – The Haymarket, 10 Wardwick, Derby

A report of the Director of Corporate Services was considered, which gave details of an application for a provisional Public Entertainments Licence at The Haymarket, 10 Wardwick, Derby. Additional information was circulated to the Sub Committee, which included a code of practice and a statement relating to the minimum price of a unit of alcohol, which the applicant voluntarily undertook to implement. Mr Allan attended the meeting and addressed the Sub Committee.

Resolved to grant the application for a provisional Public Entertainments Licence subject to the following conditions:

- there would be a maximum capacity of 320 people
- that Public Entertainments would be 10am to 12.30am Monday to Saturday and 12pm to 12.30am on Sundays

14/03 Application for a new Public Entertainments Licence – The Peartree Inn, 155 St Thomas Road, Derby

A report of the Director of Corporate Services was considered, which gave details of an application for a new Public Entertainments Licence at The Peartree Inn, 155 St Thomas Road, Derby. The Sub Committee noted that the original applicant, Ms McDermott, had left the premises and the outstanding works have not been completed. The new licensee was invited to the sub committee, but did not attend.

Resolved to refuse the application on the basis that the new licensee would be required to submit a new application for a Public Entertainments Licence.

At this point Councillors Brown and J Hickson left the meeting.

15/03 Application to renew the Public Entertainments Licence – Bar Vida, 53-55 St Mary's Chambers, Derby

A report of the Director of Corporate Services was considered which gave details of an application to renew the Public Entertainments Licence at Bar Vida, 53-55 St Mary's Chambers, Derby. Mr Faulding attended the meeting and addressed the Sub Committee.

Resolved to renew the Public Entertainments Licence subject to the certification for the Fire Alarms Inspection being submitted to the Chief Environmental Health Officer and that all the conditions in the letter dated 16 June 2003 were complied with by Monday 11 August 2003.

At this point Councillors Brown and J Hickson returned to the meeting.

16/03 Application to renew the Public Entertainments Licence – Sergeant Peppers, 7 Burton Road, Derby

A report of the Director of Corporate Services was considered which gave details of an application to renew the Public Entertainments Licence at Sergeant Peppers, 7 Burton Road, Derby. The application was received from Ms Sarah Craddock, in her absence Mrs Geraldine Gibson attended and addressed the Sub Committee.

Resolved to refuse the application on the grounds that a number of certificates of work required to ensure the licence conditions are met were not supplied and the panel felt that every effort had not been made to ensure that they were produced in time.

At this point Councillor J Hickson left the meeting.

17/03 Application to renew the Public Entertainments Licence – Curzons, 25 Curzon Street, Derby

A report of the Director of Corporate Services was considered, which gave details of an application to renew the Public Entertainments Licence at Curzons, 25 Curzon Street, Derby. A renewal application was received on 26 June 2003 from Mr K Dakin. He was unable to attend and a representative, Mr Collins, circulated a letter from the Fire Officer and addressed the Sub Committee.

Resolved to refuse the application on the grounds that the Fire Officer's recommendations stated in a letter dated 11 June 2003 had not been completed. The Sub Committee emphasised that public safety must be paramount.

At this point Councillor J Hickson returned to the meeting.

18/03 Application for a new Public Entertainments Licence – The Norman Arms, Village Street, Derby

A report of the Director of Corporate Services was considered, which gave details of an application for a new Public Entertainments Licence at The Norman Arms, Village Street, Derby. The Sub Committee noted that a new application was received on 17 December 2002 from Mr J Soanes in respect of the Norman Arms. A new application is normally given six months to achieve compliance with Public Entertainments Licence conditions. A copy of the application was included in the report. Previously an application was made on 23 October 2000 but was refused due to unfinished work. Since then another applicant has been responsible for the premises. Mr J Soanes attended and addressed the Sub Committee.

Resolved to grant the application for a new Public Entertainments Licence subject to the following conditions:

- that the hours of operation are restricted to Friday and Saturday 7pm to 11pm and Bank Holiday Mondays 7pm to 11pm
- that the Crime Prevention Officers recommendations are adhered to
- that any entertainment is to be held in the lounge only, with a maximum capacity of 74 people
- that windows and doors are closed during entertainment
- that all outstanding certification is received by 11 August 2003.

**19/03 Application for a provisional Public
Entertainments Licence – Foo Baa, Old
Blacksmiths Yard, Sadler Gate, Derby**

A report of the Director of Corporate Services was considered which gave details of an application for a provisional Public Entertainments Licence at Foo Baa, Old Blacksmiths Yard, Sadler Gate, Derby. A provisional application was received on 29 April 2003 from Mr P Bernstein in respect of Foo Baa. An objection was received by a member of the public. Both Mr Bernstein and the objector, Mr Economides, attended and addressed the Sub Committee.

Resolved to grant the provisional Public Entertainments Licence subject to the following conditions:

- that toilets be provided on the ground and first floors for both men and women
- that there will be a separate toilet for disabled people
- that door supervisors must be part of the Door Supervisors Scheme and are adequately supervised and managed
- that the hours for Public Entertainment be limited to Monday to Saturday 10am to 2am, Bank Holidays 12pm to 2am and Sundays 12pm to 12.30am.

**20/03 Application to renew the Public Entertainments
Licence – Diva, Gower Street, Derby**

A report of the Director of Corporate Services was considered which gave details of an application to renew the Public Entertainments Licence at Diva, Gower Street, Derby. A renewal application was received on 4 July 2003 from Mr J Stevenson in respect of Diva. Although invited Mr Stevenson did not attend.

It was noted by the Sub Committee that the application fee had not been paid, which meant that the application was not valid. A letter was sent out to Mr Stevenson on 25 July 2003 giving him 14 days to pay the fee in cash.

Resolved to defer the item to the next meeting of the Sub Committee to give time for the application fee to be paid in full.
