ITEM 10

Promoting prevention and addressing the wider determinants of health from an acute trust

Purpose

- 1.1 The health needs of our population are well documented and we are clear about where we need to prioritise our efforts to improve health and life outcomes for our residents.
- 1.2 This report examines work undertaken during the last 12 months at University Hospitals of Derby and Burton (UHDB), and the impact thereof, to promote a prevention approach within treatment pathways and address the wider determinants of health by establishing direct referral routes to relevant local authority services.
- 1.3 A presentation will be given at the meeting.

Recommendation

2.1 To note the outcomes of the work and make comment.

Reason(s)

3.1 The Health and Wellbeing Board plays a key role in providing direction to the system on how to improve health outcomes for our residents. The report provides insight into the impact of promoting prevention and addressing the wider determinants of health to patients accessing secondary care services.

Supporting information

- 4.1 The health inequalities and comparatively poor health outcomes in the city have been well documented and previously discussed at the Health and Wellbeing Board. All partners across our system have a contribution to make in addressing health inequalities and, recently, national targets have been introduced by the NHS to ensure acute trusts are offering secondary prevention services to their patients. The presentation describes an extension of this work beyond the targets set for tobacco dependency treatment and alcohol care teams to incorporate the wider prevention agenda and address the wider determinants of health.
- 4.2 The Florence Nightingale Community Hospital site was initially used to promote secondary prevention services and the development of partnership working informed by the population health needs of Derby City.

4.3 This model was extended further to develop population health improvement approaches across UHDB.

Public/stakeholder engagement

5.1 Significant stakeholder engagement has taken place throughout this work, with a range of partners across the system, particularly local authority, PCNs and JUCD and most notably with clinicians from a number of specialties across the Trust.

6.1 None.

Financial and value for money issues

- 7.1 It is believed that increasing the breadth and opportunity for preventative measures and tackling key contributors to health and wellbeing such as housing offers value for money and will positively impact on health care need and demand for services.
- 7.2 Some one-off in-year funding has been used to support the work undertaken which poses some risk to sustainability. This, however, is not specifically raised for discussion as part of this report.
