# Taxi Licensing Administration and Compliance Activities - Quarter 1 and Quarter 2, 2015/16

#### SUMMARY

Using a risk-based approach, Licensing Enforcement Officers will often identify vehicles to inspect that appear to fall below the Council's standard for licensed vehicles. Therefore, it is important to recognize that these statistics do not indicate the general condition of all of the licensed fleet.
- 4.4 The information contained at Appendices 4 and 10 sets out the age of the vehicles that were inspected during Quarter 1 and Quarter 2 respectively.
