# Report on the Children and Young People's Partnership: Parenting Strategy

## RECOMMENDATION

1. To note the contents of the Parenting Strategy 2007-2008, produced on behalf of the Children and Young People's Partnership in Derby

# **REASON FOR RECOMMENDATIONS**

- 2. The Local Authority has a responsibility and leadership role for promoting positive parenting in the city. The Parenting Strategy sets out the vision and key priorities for supporting and promoting parenting in the city, through a partnership approach.
- 2.1 A Partnership Steering group is established to monitor, review, identify gaps in parenting support and coordinate parenting programmes and activities in the City. This Steering group is representative of the partners in Derby that provide a range of parenting support and is fully inclusive of the Third Sector The steering group is underpinned by a network of parenting practitioners working across Derby

# SUPPORTING INFORMATION

- 3. Consultation with parents, carers, children and young people supported the development of the strategy as well as those views of the children's workforce.
- 3.1 An action plan for 2007-2008 is contained within the strategy which is being implemented through the coordinating Parenting Steering Group.
- 3.2 A Parenting Coordinator has been appointed, based within the Children and Young People's Department of Derby City Council, with the aim of:
  - Updating the mapping of parenting activities and support to produce a resource directory
  - Coordinating the range of parenting programmes across Derby
  - Facilitating the Parenting network meeting
  - Facilitating a city wide Parents Forum
- 3.3 The Parenting strategy has been launched at two events. Firstly on 7.9.07 for practitioners and managers in the city and on the 15.9.07 for parents, carers and children, both events were positively received
