

Budget and Policy Framework

297/05 Refreshing Derby's Local Area Agreement

The Council Cabinet considered a report on Refreshing Derby's Local Area Agreement which detailed the final draft of the Local Area Agreement LAA. Derby's refreshed LAA for 2006 covered four areas of activity or blocks:

- Children and Young People
- Economic Development and Enterprise
- Healthier Communities and Older People
- Safer and Stronger Communities.

Future governance arrangements for the LAA were being considered as part of the Derby City Partnership review to be concluded at the end of March 2006.

Decision

To recommend to Council:

- 1. To approve the final draft Local Area Agreement as the basis for agreement with the Government.
- 2. To confirm the delegated authority to the Chief Executive, in consultation with the Leader of the council and the Director of Regeneration and Community, to

- conclude negotiations on behalf of the Council and its partners to this agreement.
- 3. To note the role of the Council as the accountable body for the agreement and the governance arrangements necessary to support this role.
- 4. To note the further work to be undertaken with Derby City Partnership to develop appropriate governance arrangements to enable partners to work towards agreed outcomes under a 'single pot' and that these arrangements will be subject to further Cabinet approval.
- To approve, subject to the agreement of Derby City Partnership and the need for Cabinet agreement to any later changes, the initial conditions to apply to disbursements by the Council of pooled LAA funds in 2006-07, as set out in the attached report.

32/05 Proposal to the Casino Advisory Panel

The Committee considered a report that set out details of a proposal submitted to the Casino Advisory Panel for permission to locate a large casino in Derby.

The Casino Advisory Panel is an independent panel that was established in September 2005 to advise the Government on the geographical areas in which the new types of casino created by the Gambling Act 2005 would be located. One regional casino, eight large and eight small casinos would be permitted. 41 local authorities had applied for a large casino.

On 31 January 2006, the Panel invited formal applications from local authorities who wanted to have a new casino in their area. Proposals needed to reach the Panel by 31 March 2006. Derby Cityscape submitted a provisional application, on behalf of the Council, subject to the final decision being made by the General Licensing Committee.

David Marshall the Director of Development at Derby Cityscape considered that the application had been supported by Derby City Partnership and the Strategic Partnership for Derby and Derbyshire. It was reported that the proposal had been endorsed by the Strategic Partnership in February 2006 and the Derby City Partnership in March 2006.

Work on the bid had been completed in conjunction with 'Tribal' consultants. Tribal had advised of a minimum of 250 extra jobs and a catalyst for other opportunities, such as a hotel and conferencing facilities.

Councillor Skelton asked why a casino was necessary when Gala Bingo had just received a new licence. David Marshall responded that the casino proposal was for 40,000 sq ft, whereas Gala Bingo was 25,000sq ft.

Councillor Allen considered that there had not been sufficient consultation, especially as many Councillors hadn't seen the proposal prior to the meeting. He also considered that Tribals' report did not focus on the social impact of the casino. John Tomlinson

responded that the application only reached the licensing team three days before the application deadline and therefore did not leave enough time to consult the Committee on the proposal before submission.

Resolved

- 1. to note the Casino Advisory Panel's role in the establishment for new types of casinos and the procedure involved in selecting locations for their operation
- 2. to recommend to Council that it supports the application to locate a large casino in Derby.
- 3. to ask officers to include in the report to Council information on the negative aspects of gambling.

Councillors Allen and Skelton requested that their votes against the decision be recorded.
