## 52/03 Minutes

**Agreed that the Minutes of the Area Panel 4 meeting held on 21 January 2004, be confirmed as a correct record, subject to the following amendments:**

## 59/03 Area Panel Budget Proposals 2003/04

A report of the Assistant Director of Community Policy was considered which set out details of five applications for funding which had been received. These were:

1. To consider whether to support the application received from Mickleover Gymnastics Club for funding for new gymnastic equipment and training aids. Grant requested - £4,790.
2. To consider whether to support the application received from the Mickleover Community Action Group for funding for installation of a sports wall on Vicarage Road Park. Grant requested - £5,000.
3. To consider whether to support the application received from Councillor Crosby for funding for installation of two benches on Sunnydale Park. Grant requested - £1,000.
4. To consider whether to support the application received from Councillor Skelton for funding for landscaping along Stenson Road by the Railway Bridge. Grant requested - £1,105.

5. To consider whether to support the application received from Bal Sanskar for funding for equipment for the youth group which caters for 4-14 year olds. Grant requested - £1,199.

### **Options Considered**

The Panel assessed the applications for funding against the agreed criteria and assessed the applications for funding against priorities.

### **Decision**

To award funding to the following applications:

- Installation of two park benches – Grant £1,000
- Landscaping along Stenson Road – Grant £368  
*It was agreed to allocate this application the remainder of the annual allocation for Area Panel 4, which totalled £368, to enable planting on the bank. The applicant was advised they could submit a new application in the next financial year for any additional funding required.*

To defer decision on the following application:

- Mickleover Community Action Group.
  - The Panel requested more information about how the proposals to install a youth shelter and the Pavilion could be coordinated with a sports wall.

- Mickleover Gymnastics Club – Grant £4,790.
