## **Update on recommissioning of Children's Health Services**

### **SUMMARY**

- 1.1 This report enables the Children and Young People Overview and Scrutiny Board to receive a presentation to update members on the recommissioning of Children's Health Services from Frank McGhee, Director of Commissioning.
- 1.2 The presentation is provided at the request of the Children and Young People's Board to further update members on the progress which has been made relating specifically to the recommissioning of Children's Health Services.

## SUPPORTING INFORMATION

- 4.1 The Children and Young People's Board received a report in March 2014 which provided a summary of the progress on key children, young people and family priorities which have been developed from the Health and Well-being Strategy – everyone's business, the NHS Outcomes Framework (2013/14), the Public Health Outcomes Framework (2013 to 2016) and the Derby Children and Young People's Plan (2012/13).
- 4.2 The Board was informed that strategic commissioning intentions were developed in discussions with key commissioners across the health economy in Derby which resulted in considerable support for an integrated commissioning approach to delivering better health outcomes.
- 4.3 The Health and Well-being Board received a report in May outlining a proposal to re-commissioning children's health services across the City and Southern Derbyshire Clinical Commissioning Group (CCG). This proposal to improve the current delivery model and to closer align children's health services to early help provision was supported by the Health and Well-being Board.

A report has also gone to Southern Derbyshire CCG outlining and seeking support for this proposal. The CCG has also supported this re-commissioning programme.

We have included alignment of Local Authority Public Health funding within this re-commissioning programme. This covers future arrangements for health visiting and school nursing. A report is going to Cabinet seeking support for the inclusion of public health funding.
