**84/05 Derby's Community Strategy 2006-2009, the 2020 Vision**

The Commission considered a report on Derby's Community Strategy 2006-2009, the 2020 Vision. The report presented the draft Community Strategy and gave details of the process gone through to develop the Community Strategy to the point it was at.

The Commission considered a presentation on the Home Office proposals on a Co-ordinated Prostitution Strategy, which gave details of the Home Office proposals, the effect this would have on Derby. The presentation also outlined the recent work of the Community Safety Partnership in dealing with prostitution within Derby.

### 86/05      Housing Capital Programme

The Commission considered a report of the Corporate Director of Resources on the Housing Capital Programme for 2006/07 – 2008/09. The report detailed that the housing capital programme would include schemes financed both from service-specific allocations and discretionary corporate funding.

### 87/05      Performance Eye

The Commission considered a report of the Director of Corporate and Adult Services on the Performance Eye statistics for quarter three 2005 – 06 and a presentation on performance indicators BV79a, BV79bi and BV79bii.

It was reported that the indicator BV79a – percentage of cases for which the calculation of the amount of benefit due was correct, was produced by a random sample check of 10% of all cases. A mistake could be a technical error as well as financial. It was expected that the year end figure would be 97% accuracy which would be a significant improvement to the previous years figures.

It was reported that indicators BV79bi – percentage of recoverable overpayments (excluding Council Tax Benefit) recovered and BV79bii – percentage of overpayments

recovered during the period and HB overpayments identified were both new indicators so the targets set were worked out by the department's track record.

It was reported that the original target for BV79bi was 85% which was reduced to 80% to make it more realistic. In quarter three a team leader post became vacant and sickness affected the statistics, but the situation was resolved meaning the year end figure was expected to be 80%. The vacant post and sickness also affected the BV79bii indicator.
