06/14 Minutes of the Previous Meeting and Matters Arising

08/14 Support from the RE Adviser to the SACRE

Steve Ford introduced himself to Members as the new Lead Officer to support the SACRE, who had taken over from Alan Stubbersfield, the RE Adviser to the SACRE.

09/14 SACRE Membership, Resignations and Vacancies

The clerk to the SACRE reported that there had been two resignations since the last meeting of the SACRE and that they were from Wendy Jordon (Salvation Army) and Ruth Dolby (Jewish Faith). Members agreed that the clerk to the SACRE would send out letters of thanks.

Eve Sacker was introduced as the new Jewish Faith representative.
