Resolved to approve the minute and recommendation 170/13 of the Council Cabinet dated 12 February 2014

80/13 Members' Allowances Scheme 2014/15

Council considered a report of the Strategic Director of Resources relating to the recommendations of the Independent Remuneration Panel for the establishment of a Members' Allowances Scheme for 2014/15.

Councillor Bayliss thanked the Independent Remuneration Panel for their wellconsidered and balanced report, and moved one amendment, seconded by Councillor Hickson, that paragraph 4e of the motion be amended to read:

'that the Council ceases the practice of funding new Members' broadband connections, to reflect that employees do not receive a similar benefit'

The amendment was approved

Resolved:

- 1. To continue the established practice of linking the annual uplift of Members' Allowances (both Basic Allowance and Special Responsibility Allowances) to the increase in Council employees' salaries. For 2014/15 this will be a 1% increase, with effect from 1 April 2014.
- 2. To vary the conditions within Schedule 3 of the Scheme, relating to travelling expenses, to remove consideration of Members' homes as a place of work. To comply with HMRC guidance, the sole place of work will be The Council House and journeys between it and the Member's home will not qualify for a mileage allowance.
- 3. To make no changes to the Special Responsibility Allowances (SRA), other than the 1% uplift, until the Annual Meeting of the Council on 11 June 2014, recognising that the decisions on constitutional

appointments, when all roles are appointed to, is the logical point to introduce change.

- 4. Subject to recommendation 2.3 being accepted, then at the time of the Annual Meeting the following recommendations be introduced:
 - a. Councillors continue to be mindful, when making appointments at the Annual Meeting, that payments of Special Responsibility Allowances should be restricted to no more than 50% of all Members, currently a maximum of 25. The IRP recognises the particular commitment made by those who serve on Licensing Committees and Adoption and Fostering Panels and recommends that those SRAs should not be included in the calculation of the 50% target
 - b. to increase the payment of the SRA to members of the General Licensing Committee and the Taxi Licensing and Appeals Committee, to a level equivalent to 6.25% of the Leader's Allowance, to reflect the time commitment and responsibility of these roles. There is a requirement that each member will attend at least 15% of the meetings called and the Panel wishes to receive a report of attendances at its meeting in 2015, to ensure compliance with this condition
 - c. to reduce the payment of the SRA to vice-chairs of Scrutiny Boards, to the level currently paid to members of the Adoption and Fostering Panels, and that proposed for members of Licensing Committees, being 6.25% of the Leader's Allowance.
 - d. to introduce a condition that the SRA for the Deputy Leader of a political group, be payable only if that group has at least ten members, that number being the minimum required to request a recorded vote in a meeting of Council, under Council Procedure Rule 71
 - e. that the Council ceases the practice of funding new Members' broadband conections, to reflect that employees do not receive a similar benefit'

'This Council is concerned about the levels of domestic violence across the country, but most particularly within the City of Derby, where domestic violence is a growing issue of concern and where the Council has a direct role in combatting the issue.

The levels of abuse are astonishing with a recent survey showing that 30% of the female population has been subject to domestic violence of one sort or another and that this may be an underestimate, as victims are often reluctant to report this crime

Set up a cross party Domestic Violence Review Panel comprising members and other appropriate agencies to :

- (a) consider and evaluate the levels of domestic abuse within the City
- (b) to 'dip sample' the way that cases have been managed and their outcomes
- (c) to discuss and disseminate the best possible levels of professional practice within the City
- (d) to consider training on this issue for members
- (e) to make recommendations to Cabinet about future resources, training and awareness'

2 Standards Committee

It was moved by Councillor Hickson and seconded that:

'The current arrangements for the Standards Committee at Derby City Council are a serious cause for concern and are not providing the reassurance that the public want or need and are in danger of disenfranchising the lay members that sit on it.

Applying Widdecombe rules, to the constitutional make-up of the Committee, are a barrier to fair adjudications and the inability of lay members to have any meaningful role in the adjudication process, is seen as a very serious obstruction to achieving decisions, which are in the public interest.

Council therefore calls on Council Cabinet to bring forward proposals, for a revised structure for this committee, if it is to exist after the Annual General Meeting of the Council by

- (a) reducing its membership to one member of each political group so that there should not be a majority of any one particular political party on the Committee and
- (b) seeking ways to strengthen and enhance the role of the lay members and making suitable representations to Government and the LGA if that outcome cannot be achieved locally'

It was moved by Councillor Roberts and seconded that the motion be amended to read:

'Council recognises that there are concerns, particularly within the minority groups, about the manner in which the Standards Committee operates. All council committees are currently formulated under the Widdecombe procedures and it is suggested that for the Standards Committee this should be reviewed. Council therefore proposes that the Standards Committee structure is considered as a Topic Review by the Resources and Governance Overview and Scrutiny Board. Council, however, is aware that the lay representation is covered by statutory guidance and as such is not within the Council's purview to amend'

The amendment was not approved

3 Bombardier

It was moved by Councillor Hickson and seconded that:

'This Council warmly congratulates Bombardier on its recent success in achieving the Crossrail contract. The Council is delighted that the United Kingdom's last train manufacturer has an exciting future and that it is remaining in this city, where it belongs and where it adds so much value to Derby.

Resolved that:

remaining in this city, where it belongs and where it adds so much value to Derby.

Council wishes the management and the workforce every success moving forward.'

4 Democratic Integrity Panel

It was moved by Councillor Hickson and seconded that:

'Council remains concerned about the on-going potential for electoral fraud, following the prosecutions and convictions for corrupt electoral practices in Arboretum Ward.

Council is concerned that public confidence in the voting arrangements managed by this Council were severely damaged as a result of the prosecutions that occurred.

Council therefore requests that the Council Cabinet immediately sets up a formal cross party Democratic Integrity Panel

The panel should be chaired by the Council's Chief Legal Officer and Returning Officer and should have a membership made up from members from each political group, political agents, the Police and such other parties as may have a legitimate interest in the election processes

The role of this new panel shall be to make sure that corrupt electoral practices are driven out of the City and to recommend whatever measures are necessary, to make sure that polling procedures are fair and untainted in future, and that public confidence is restored in the electoral process.'
