### 35/06 Proposal to Co-opt Mr Joe Russo to the Commission

### 36/06 Home to School Transport

The Commission considered a report from the Corporate Director for Children and Young People on the home to school transport review 2005-6. The report detailed the changes that had taken place and the savings resulting from the changes in the appeals procedure and the introduction of the new policy.

Simon Longley – Assistant Director, Strategic Support, reported that there had been a reduction in the number of appeals in 2005/6 compared with 2004/5 as the revised policy and guidance was much clearer and parents have to identify their specific grounds for appeal against criteria in the guidance.

The Chair asked for the Commission's thanks to be passed on to Officers for the work they had put in to make the new system work. The Commission were particularly pleased that there had been no complaints.

## 38/06 Performance Eye

The Commission considered a report from the Director of Corporate and Adult Social Services detailing the first quarter 2006-7 performance eye data relating to the Commission's scorecard on Performance Eye. Appendix 3 of the report included a more detailed commentary on four areas for concern that were requested by the Chair and Vice Chair. These were:

- CF/A2 (BV50, CP2.2ai) - % of young people leaving care with at least one GCSE
- CF/A4 (BV161, CP2.3bii) - % of looked after children engaged in education/training/employment at 19
- CF/C23 (BV163) - % of looked after children adopted
- CYP 2.6 - % of families with up to date information about services in Surestart areas

Simon Longley – Assistant Director, Strategic Support, provided further information on each of the four indicators identified by the Commission and advised that he would provide further information relating to CYP 2.6 to members of the Commission before the next meeting
