

INTEGRATED CARE PARTNERSHIP 19 June 2024 Summary of Reports

ITEM 05 Progress Evaluation of VCSE Memorandum of Understanding MoU

REPORT ABSTRACT

Last year, following extensive consultation, the ICP (and ICB) signed off a VCSE sector Memorandum of Understanding (MoU). This report shares a 12 months review.

To review progress, an evaluation tool was developed which was cascaded throughout system partnership structures, networks, forums and individual organisations. In addition to feedback received, the progress report draws on other work including the review of VCSE infrastructure, VCSE Alliance activity and work of procurement and commissioning.

The context for developing partnership working with the VCSE sector in the last 12 months has been challenging with service pressures, financial challenges and recent announcements on consultation regarding potential funding cuts.

The report highlights areas of progress and areas of continuing challenge. It suggests that developments are still putting at risk the system aspiration for a diverse, sustainable, local VCSE sector that can underpin and play a transformational role as we seek to increase a preventative approach and tackle health inequalities and determinants of ill health. It also pulls out potential priorities for the year ahead.

ITEM 06 REPORT TITLE: LGA Facilitated Workshop Follow Up

REPORT ABSTRACT

This report provides further follow-up to the Integrated Care Partnership (ICP) on the development workshop between the two Health and Wellbeing Boards (HWBs) and ICP, facilitated by the Local Government Association (LGA) held on the 29th February 2024.

It provides an overview of work undertaken, and follow-up with the LGA since this session. The LGA has offered further capacity to support the Derbyshire system in developing effective partnership working until the end of June. The report recommends that this offer is accepted and facilitated discussions are held to support shaping a shared view of the challenges and opportunities and next steps.

ITEM 08

REPORT TITLE: Tobacco Control in Derby and Derbyshire

REPORT ABSTRACT

Smoking is the single leading cause of preventable death, causing over 1,354 premature deaths and nearly 11,000 hospital admissions in our ICS area annually. Whilst smoking rates have reduced over the last decade, at least 1 in 7 residents in our ICS still smoke, and around 1 in 5 in the area with the highest prevalence (Derby). Smoking is responsible for at least half of the difference in life expectancy between the least and most deprived in society. There are currently 130,000 smokers in Derby and Derbyshire. Tackling smoking is a key factor in improving population health and outcomes, reducing inequalities, building resilience into health and social care and help lift people out of poverty.

If we are to achieve a smoke free Derby and Derbyshire by 2030, this report identifies that we need to re-focus our efforts, take a wider partnership approach and move from a focus primarily upon treating individual smokers tobacco dependency, to a tobacco control approach that is based upon a multi-component population strategy and actions that include the key elements of tobacco treatment, prevention, enforcement and marketing.

REPORT TITLE: Stay Well Update - Role and function of the Population Health Management Steering Group and next focus for the Stay Well Sprint

REPORT ABSTRACT

This report provides an update on progress made on the Stay Well Key Area of Focus (KAOF) of the Integrated Care Strategy since the last meeting of the ICP.

It aims to bring to the attention of the ICP, issues relating to the role and function of the Population Health Management (PHM) Steering Group and potential future focus of the group to support the Stay Well KAOF.

In addition, it outlines, and seeks approval, for the proposed focus for the next Stay Well sprint on adult obesity and intention to carry out a 'pre-sprint' phase.
