**25/12 Taxi Licensing and Enforcement Activities 2012/13 -
Quarter 2**

The Committee considered a report which provided information on the activities the licensing service had undertaken during quarter 2 of the 2012/13 financial year.

Some Members of the Committee expressed concerns about the two strike suspension rule on enforcement and the requirement to attend Taxi Licensing Sub Committee for two suspensions in any 12 month rolling period.

26/12 Advertising Update

The Committee considered a report which stated that the Committee had previously agreed to allow advertising on private hire door signs and to amend the existing private hire vehicle condition 11 and the existing hackney carriage advertising policy. A consultation process had been undertaken and the report updated Members on the outcome of this process.

Resolved to note the outcome of the consultation processes and to approve the recommendation of the Strategic Director of Neighbourhoods, following consultation with the Chair, to introduce standardised door signage with and without advertisements on, in line with the details set out in the report.

27/12 Taxi Licensing Fees and Charges 2013/14

The Committee considered a report which provided information on the proposed licence fees and charges for driver, vehicle and operator licence and other charges for 2013/14.

The Committee requested a report from officers be presented to this meeting.
