

## **Health and Wellbeing Strategy Development**

### **SUMMARY**

- 1.1 A number of processes have been undertaken/ are planned to support the development of the Health and Wellbeing Strategy. These include the 'Living Well for Longer' event which took place in March and the collation of shared priorities and objectives of local partners from a desk top exercise of reviewing local plans.
- 1.2 Information from these processes along with key findings from the Joint Strategic Needs Assessment will be presented to the Board. The Board will be asked to agree a number of priority issues for potential focus within the Health and Wellbeing Strategy.
- 1.3 A number of workshops are planned for early June. At these events, stakeholders will be presented with the priority issues identified by the Board along with information from the JSNA etc.
- 1.4 Following this work a Health and Wellbeing Strategy will be drafted and presented to the Health and Wellbeing Board in July for approval.
