2.3c	31	Develop DerbyLive! to provide a sustainable model for performing arts in the city and support the amateur theatre community	Could the performance measure on 'premiere performance spaces' be defined?  Include a reference to NI 11 – Engagement in Arts in the 'Other links' column  An additional performance measure should be included to monitor audience figures for DerbyLive! productions.
4.1d	41	Improve the outcomes for most vulnerable groups	Re-word to 'improve educational outcomes for the most vulnerable groups'
5.2	53	Reduce under age alcohol consumption and smoking by increasing enforcement of underage sales legislation	In light of the recent review of alcohol licensing, two additional measures should be included:  - The number of enforcement operations undertaken out of hours  - The number of joint operations undertaken with partner organisations
5.3d	56	Increase the number of evidence based parenting programmes through the implementation of the parenting strategy	An additional measure should be added to assess the quality of the programmes, for example, evaluation of effectiveness.
