### **Compliance with Contract and Financial Procedure Rules**

The Board received a report of the Leader of the Council and Cabinet Member for Strategy, Governance and Finance and the Director of Financial Services on Compliance with Contract and Financial Procedure Rules.

Members noted that the report sought Council Cabinet approval for the following:

- Bid for and acceptance of new funding of £0.344m from the Football Foundation to develop a PlayZone facility in Alvaston Park.
- Acceptance of the Section 31 Local Stop Smoking Services and Support Grant of £0.375m from the Department of Health and Social Care -DHSC
- Acceptance of Department of Levelling Up Housing and Communities (DLUHC), Homelessness Prevention Grant of £1.111m in 2024/25.
- Acceptance of DLUHC, Homelessness Prevention Grant - Top Up Grant of £0.312m in 2024/25.
- Acceptance of the Final 2024 Household Support Fund

The Executive Scrutiny Board resolved to recommend that Cabinet avoid match funding coming from general parks funding, and instead seek to use alternative funding pots and support from other interested parties, including the friends of parks groups.**
