## **Strategic Partnership and Vision Commission Update**

### **Purpose**

- 1.1 The Corporate Services Scrutiny Review Board requested an update on Strategic Partnerships and Vision Commission as part of their forward plan.
- 1.2 A presentation will be given at the meeting.

### **Recommendations**

- 2.1 To consider the latest update on Strategic Partnership working and the Vision Commission as presented at the meeting.

### **Reasons**

- 3.1 Partnership working is key to delivery of Council priorities and wider outcomes for the City, including recovery from COVID-19. The Vision Commission will set the long-term aspirations for the city.

### **Supporting information**

- 4.1 The Derby Partnership Board provides collaborative leadership for the city. There are currently a number of partnership outcome boards also in place:
  - Children Families and Learners Board
  - Derby Renaissance Board
  - Health and Wellbeing Board
  - Leisure Culture and Tourism Board
  - Safer Board
  - Stronger Board
- 4.2 An Economic Task Force and Community Recovery Board were created during 2020 in the wake of COVID-19 to support the city's recovery from the pandemic. In December 2020, the Council published a draft Recovery Plan alongside its budget proposals for consultation which can be viewed here: [derby-city-council-budget-consultation-2021.pdf](#)

- 4.3 A review of partnership boards and working groups is currently taking place, overseen by Derby Partnership Board.
- 4.4 The establishment of a Vision Commission was approved by Council Cabinet in March 2020. This has been paused in light of COVID-19 but plans remain in development.
- 4.5 A presentation will provide an update on Strategic Partnerships and the Vision Commission.

**Public/stakeholder engagement**

- 5.1 There is ongoing engagement with partners through the strategic partnerships in place. The draft Recovery Plan (published alongside the Council’s budget proposals) is currently out to public consultation until 17 January 2021.

**Climate implications**
