

## **EIA for Proposed Ending of Service Contracts for Targeted Sexual Health Promotion/Education: Impact on Equality Groups**

The services affected by proposed changes are primarily targeted at groups of people/communities with protected characteristics under the Equality Act 2010. Due to the nature of these services, it is likely that there may be an impact on at least one or more of the Equality Groups. Organisations potentially affected may also deliver other services that are not commissioned by Derby City Council. The ending of service contracts for targeted sexual health promotion/education may therefore potentially affect the provider's ability to deliver those services not commissioned by Derby City Council.

### **Scale of any negative impact:**

This document summarises the impact that potential ending of service contracts for targeted sexual health promotion/education would have on each specific Equality Group. This has been done by:

- Looking at the service according to the support provided to the main Equality Group
- If a service provides a significant level of support for a second Equality Group then it will be listed under both Equality Groups
- Capturing the impact that ending of Derby City Council service contracts for targeted sexual health promotion/education will have on Equality Groups accessing other services provided by the affected organisation but not commissioned by Derby City Council.

### **Scale of any negative impact:**

Based on the budget proposals set out in the public consultation, the ending of service contracts for targeted sexual health promotion/education are likely to have a negative impact on people from the identified Equality Groups. The extent of this impact will depend on any mitigating action taken by the Council or organisation affected.

	<p>MAT teams</p> <ul style="list-style-type: none"> <li>• Advice and support for parents of young people</li> <li>• Sign-posting safeguarding issues relating to young people</li> </ul> <p>These services are primarily carried out at a range of venues across Derby including schools, colleges and youth centres, with a proactive focus on those areas that are most deprived or have the highest rates of teenage pregnancy. Services delivered include a range of group work, class sessions and one-to-one support. YPSHSS work closely and in conjunction with Contraception and Sexual Health (C&amp;SH) services provided by Derbyshire Community Health Services to deliver joined up sexual health provision for young people.</p> <p>Loss of these services would potentially result in increased pressure on schools to deliver additional sex and relationship education, particularly to adolescent and young men. YPSHPSS education, awareness and training services are used and accessed by all schools across Derby with the exception of just two schools.</p> <p>Loss of these services would also have a significant negative impact on young people as it will potentially reduce awareness and knowledge around sexual health, reduce opportunities to sign post and access sexual health services and increase the chance of risk taking behaviour among young people. There is no certainty as to whether the remaining C&amp;SH and C-card condom distribution services would be able to continue with the loss of YPSHPSS. This may mean that young people may be forced to travel to the city centre to access equivalent services as a result of the ending of this service contract.</p>
