Constitutional Amendments

Purpose

- 1.1 This report seeks to amend the Council Constitution, in order to provide the necessary authorisation for officers to discharge powers granted under a range of legislation relating to civil enforcement.
- 1.2 Officers in the Public Protection and Streetpride department have undertaken a review of the Council's Scheme of Delegations, in relation to the list of legislation under which the Director of Public Protection and Streetpride may appoint authorised or proper officers.
- 1.3 The exercise has recommended the removal of five obsolete pieces of legislation from Part F of the Scheme of Delegations, as well as the inclusion of twelve pieces of primary legislation not currently listed. Further details of the proposed changes are provided at Appendix 1; proposed amendments to the Scheme of Delegations are detailed at Appendix 2.
- 1.4 This work forms part of a wider review of the Scheme of Delegations contained within the Council Constitution, which will be presented to Council in due course.

Recommendation

- 2.1 To grant authority to the Director of Public Protection and Streetpride to appoint authorised or proper officers for the purposes of exercising statutory functions related to the primary legislation listed at 4.4 of the report.
- 2.2 To authorise the Monitoring Officer to make appropriate amendments to the Scheme of Delegations within the Council Constitution, as detailed at Appendix 2.

Reasons

3.1 To ensure legislation granting powers to officers within the Scheme of Delegations is up to date and accurate.

Supporting information

- 4.1 Officers in the Public Protection and Streetpride department have undertaken a review of both the statutory powers and functions listed under the responsibility of the Director of Public Protection and Streepride within Part F of the Scheme of Delegations. Details of the proposed changes are listed at Appendix 1.
- 4.2 This work forms part of an on-going wider review of the Scheme of Delegations, however approval is necessary to allow officers to discharge powers related to the Acts listed as expediently as possible.
- 4.3 The review has recommended the removal of the following obsolete Acts from the Scheme of Delegations, highlighted in red at Appendix 2:
 - Animal Boarding Establishments Act 1963
 - Breeding and Sale of Dogs (Welfare) Act 1999
 - Pet Animals Act 1951
 - Riding Establishments Act 1964 and 1970
 - Scrap Metal Dealers Act 1964
- 4.4 The exercise has recommended the addition and authorisation of powers associated with the following Acts, highlighted in green at Appendix 2:
 - Accommodation Agencies Act 1953
 - Civil Contingencies Act 2004
 - Chronically Sick and Disabled Persons Act 1970
 - Companies Act 2006
 - Crime and Disorder Act 1998
 - Disabled Person Parking Badges Act 2013
 - Flood and Water Management Act 2010
 - Land Drainage Act 1991
 - Psychoactive Substances Act 2016
 - Scrap Metal Dealers Act 2013
 - Traffic Management Act 2004
 - Zoo Licensing Act 1981
- 4.6 Also included in Appendix 2 are four pieces of legislation where Council has recently granted approval for powers to be discharged, but that have yet to be reflected in the published version of the Scheme of Delegations. These changes, together with consequential amendments relating to job titles, have been highlighted in yellow.

Public/stakeholder engagement

5.1 The proposals contained in the report have been prepared in consultation with colleagues in the Public Protection and Streetpride department and Legal Services.

Other options

6.1 To maintain existing arrangements. This has been discounted on the basis that officers would be unable to exercise powers associated with the legislation listed at 4.4.

Financial and value for money issues

7.1 None directly arising.

Legal implications

8.1 Ensuring officers are properly authorised protects the council against the risk that use of the powers detailed in the report are challenged.

B Areas of responsibility

The Director of Public Protection and Streetpride is responsible for establishing the Domestic Homicide Review. The review looks into the circumstances in which the death of a person aged 16 or over has, or appears to have, resulted from violence, abuse or neglect.
