## 76/05 Apologies for Absence

## 81/05 City Council Grants to Voluntary Sector

Tony Walsh, Derby Racial Equality Council, raised concerns regarding the existing city council grants to the voluntary sector – Community Grants Budget, and felt that under the Race Equality Scheme the Council may be required to review the impact of its grant making functions towards the assisting of community groups. He felt that the Council had been a good supporter of the community and voluntary sector for a considerable period but that support was static rather than dynamic in terms of the needs of newer groups coming into the city.

Resolved to recommend that the Corporate Director, Regeneration and Community begin the process of examining how the Community Grants Budget might change to bring it in line with the Race Equality Scheme and bring proposals for change to a future meeting.

#### 82/05 Education Commission

Councillor MacDonald, Chair of the Education Commission gave a presentation on the function of the Commission, the Education remit and past and current work of the Commission.

George Mighty asked about community representatives on the Commission and was informed that Tony Walsh was the multi-faith representative. He felt that further representation of local communities was required on the commission as education was such an important issue, but that any representatives would need to have a vote, which under the current constitutional was not possible.

Resolved to ask the Education Commission to consider requesting an amendment to the Council Constitution to change the make up of the Education Commission, to enable more community representatives to be appointed with voting rights.

# 83/05 History of Derbyshire Black Police Association and Request for MECAC Membership

Theresa Peltier, Chair of the Derbyshire Black Police Association gave an oral report on the history of the Derbyshire Black Police Association and its aims for the future and give details on why it felt it would benefit both the Association and MECAC if it was granted membership on MECAC.

Resolved to ask Council to approve the appointment of a representative from the Derbyshire Black Police Association to the Minority Ethnic Communities Advisory Committee

## 84/05 Advisory Committee Reviews Update

Pam Thompson, Consultation Support Officer presented a report on the Advisory Committee Reviews Update. She reported that a consultation process had taken place and gave details of the proposed changes to MECAC.

Resolved to defer the item to a special meeting of the Minority Ethnic Communities Advisory Committee to discuss the item in more detail and allow the Committee to make an informed recommendation on the future of the Committee.

## 85/05 Traffic in Normanton

The Committee considered a report on traffic in Normanton, which detailed proposed consultation work to be undertaken to develop a strategic improvement scheme for traffic in Normanton District Centre.

George Mighty reported that the car park discussed in the report was not the car park he had originally referred to and wanted more information on what was intended regarding that car park.

Shokat Lall commented that the five year local transport plan would have details of what was planned for the Normanton area and should be something that MECAC should have a look at.

Resolved to receive a report on the five year Local Transport Plan – LTP2, with particular attention on the Normanton area.

Ann Webster, Equality Standard Project Manager, presented a report on the Equality and Diversity Plan – Consultation Results. The report gave details on the consultation which had taken place between September and December 2005 and the results of that consultation.

Shokat Lall commented that it would be interesting to see a breakdown by race and by where respondents lived for certain key questions. Isabella Stone agreed to look into the possibility of breaking the data down in that way.
