### **1/17      Mayoral Announcement**

The Mayor expressed deepest sympathies for those affected by the terror attack at Manchester Arena on 22 May 2017 on behalf of the City of Derby residents, elected members and the authority.

Members and guests stood for a minute's silence out of respect those who had lost their lives or were injured and in support of families, friends and others who had been otherwise affected by the attack.

The Mayor reaffirmed the comments made by the previous Mayor of Derby, Councillor Winter, in relation to the terror attack. With other persons now present in the Council Chamber, and upon the request of the Mayor, councillors and others present, stood for a further minute's silence out of respect for the victims and all those affected.

## 11/17 Election of Youth Mayor

*"Council further notes the findings of the Independent Police Complaints Commission which found in a report of June 2015 that there was: 'evidence of excessive violence by police officers, a false narrative from police exaggerating violence by miners, perjury by officers giving evidence to prosecute the arrested men, and an apparent cover-up of that perjury by senior officers'.*
