Gambling Statement of Principles Review 2018

SUMMARY

- 1.1 Derby City Council is the designated Licensing Authority under the Gambling Act 2005 and is required to produce a Statement of Principles which sets out how it will exercise it functions under the Act.
- 1.2 The statement must be reviewed at least once every three years.
- 1.3 The next revised document is due to be published by the end of 2018.
- 1.4 Committee considered a report in January 2018 detailing the process for this year's consultation. The committee resolved to approve the process of consultation on a revised Statement of Principles for publication by the end of 2018.
- 1.5 This report details the results of the consultation process.

RECOMMENDATION

- 2.1 To consider the information contained within the report regarding the Gambling Act 2005 Revised Statement of Principles.
- 2.2 To approve the adoption of the revised Statement of Principles set out at Appendix 2.

REASONS FOR RECOMMENDATION

3.1 To ensure compliance with the statutory requirements in Section 349 of the Gambling Act 2005.

SUPPORTING INFORMATION

4.1 Derby City Council is a designated Licensing Authority under the Gambling Act 2005 and is required to produce a Statement of Principles which sets out how it will exercise it functions under the Act.

- 4.2 In producing its statement, the Council must follow the guidance issued by central government.
- 4.3 The Statement of Principles must be reviewed at least once every three years.
- 4.4 The initial Statement of Principles was produced in 2006. It was reviewed in December 2009, December 2012 and December 2015. The next review needs to be undertaken by December 2018.
- 4.5 There is a prescribed consultation process set out in the statutory guidance that must be followed. As part of the consultation process, the Council is required to consult with:
 - The Chief Officer of Police
 - Derbyshire Fire and Rescue Service
 - Relevant Council Departments, such as planning, Environmental Health and Safeguarding Children's Board
 - HM Revenue and Customs
 - The Gambling Commission
 - Existing licence holders of gambling establishments within the city
 - Representatives or Trade Associations of existing licence holders
 - Other relevant bodies i.e. those involved with reduction in crime and disorder, child and vulnerable adult protection, voluntary and community organisations
 - Members of the public
- 4.6 The consultation was advertised on the Council's website and comments could made on-line.

In addition to this, letters informing parties of the consultation exercise were sent to:

- All the specified consultee bodies set out in Paragraph 4.5 above
- 62 existing licence and permit holders
- 224 trade bodies, breweries, intrested parties

In total, twelve responses have been received. Six expressed an interest in making specific comments, however only 5 did make comments.

- 4.7 A proposed revised version of the Gambling Act Statement of Principles is attached at Appendix 2 for consideration.
- 4.8 A table detailing the comments received and officer recommendations is attached at Appendix 3.
- 4.9 Committee Members have been given the opportunity to make comments on the officer recommendations.
