Proposal: Construction of a multi user path and ancillary works

No objection in principal but raised concerns on the width of the path; to be no wider than 2m so as not to encourage cyclists as there is already a cycle path on the opposite side of the river.

CAAC also stated that the material of the path must be carefully chosen.
