That the number of polling districts for the Allestree ward be increased from 4 to 5 resulting in polling district boundaries being re-drawn.

That the polling place for AL2 polling district be The Woodlands Hotel, Blenheim Parade.

That the polling place for AL5 polling district be St Nicholas Church, Lawn Avenue.

## **Alvaston Ward**

That the number of polling districts for the Alvaston ward be increased from 6 to 7, resulting in polling districts being re-drawn.

That the polling district for AN5 be The English Martyrs' Catholic Church.

As required by the Governance Committee, further investigation has taken place as to the best option for the AN5 polling district. It is proposed that polling remains at the Keldholme Lane Community Centre on Gilamoor Court.

## **Arboretum Ward**

That the polling place for AR5 polling district be The Stuart Hotel, London Road.

That the polling place for SP4 polling district be The 66<sup>th</sup> Derby and 1<sup>st</sup> Spondon Scout Building, Stoney Lane.
