Early Help Annual Report

SUMMARY

- 1.1 The People's Department in Derby city remains committed to ensuring. Early Help is available to vulnerable children, young people and their families to prevent escalation to (more costly and socially damaging) higher tariff services in the future.
- 1.2 The enclosed report provides a detailed overview of the past years activity in Early Help, with an action plan that outlines the planned activity for 2017-18.

2.1 For Departmental Management Team (DMT) to comment upon and approve the attached report and action plan before it is discussed and scrutinised at Inspiring Young People's Board and by Derby Safeguarding Children's Board.

REASON FOR RECOMMENDATION

3.1 This report demonstrates the volume of activity, the quality of services provided and evidence of the impact of Early Hep services in 2016-17.

SUPPORTING INFORMATION

4.1 The attached report provides an overview of the impact Early Help services in Derby have had over the past 12 months by addressing areas impact can either be judged or measured against. Derby has a range of Early Help services available across the city including Mutli-Agency Teams who are co-located with Social Work teams and complemented by Children's Centres.

The report should be read in the context of pressures being applied to Early Help services nationally and locally, which include: Children's Centre re-configuration in Derby and a reduction in front line Priority Family Practitioners from 12 to 8.

Progress this year includes: the training of 6 Children's Practitioners in Systemic Family techniques, which is part of Improving Access to Psychological Treatment (IAPT) work that is taking place and 5 practitioners in Early Help have either been trained or are in the process of being trained in Cognitive Behavioural approaches.

Early Help continues to be delivered against a background of national increases in the number of contacts and referrals to Children's services, funding reductions from central government, an increasing population and changing demographics.

The report informs on progress to date, action planning for 2017-18, including the revised model of Early Help to schools.

5.1 The annual report provides a means of capturing information on the performance of Early Help services and is used in various fora such as Inspiring Young People's Board, DMT and Derby Safeguarding Children's Board to give an overview on progress and allow scrutiny of services to ensure there remains a firm grip in this service area going forward. The action plan ensures that HOS' and managers in Early Help services maintain a performance and quality focus throughout the year and remains an effective performance and quality assurance tool.
