## **Derby City Dementia Strategy 2014-2016**

## **SUMMARY**

- 1.1 Derby City Council and Southern Derbyshire CCG have refreshed the Derby City Dementia Strategy (2014-2016).
- 1.2 The strategy was developed following wide-scale engagement with people affected by dementia including families and carers.
- 1.3 The strategy contains an action plan that mirrors the broad range of outcomes within the National Dementia Strategy (2009).
- 1.4 The Strategy and associated implementation plan is being overseen by the partnership Southern Derbyshire Dementia Implementation Group, which in turn reports to the Integrated Care Implementation Group (part of the partnership Integrated Care Programme).

#### RECOMMENDATION

2.1 To note the Derby Dementia Strategy and implementation plan for 2014-2016.

#### REASONS FOR RECOMMENDATION

- 3.1 The Derby City Dementia Strategy has been approved by Council Cabinet and Southern Derbyshire CCG Board. The strategy has also been subject to engagement from local people with dementia and their carers.
- 3.2 The action plan contained within the strategy will form the basis of a more detailed and on-going implementation plan to be monitored and delivered by the local partnership Southern Derbyshire Dementia Implementation Group.

#### SUPPORTING INFORMATION

- 4.1 Derby's first Dementia Strategy was developed in 2010 following significant engagement with local people affected by dementia including families and carers, and local professionals over a series of months; the action plan expired in 2012.
- 4.2 Since the first National Dementia Strategy was produced in 2009, there has been a strong and reinvigorated national policy emphasis on dementia.
- 4.3 Derby's updated Dementia Strategy contains:
  - An overview of the national policy context
  - a projection of the numbers of people expected to have dementia, now and in forthcoming years
  - A summary of feedback received as a result of the engagement work held locally
  - A summary of what has been achieved by the local partnership since the first Dementia Strategy in Derby in 2010
- 4.4 The strategy also contains an updated implementation plan detailing actions to be taken to address local priorities up until 2016. These actions span the broad range of objectives reflected within the national strategy and include:
  - Developing opportunities to support prevention of dementia;
  - Promoting awareness and reducing stigma around dementia particularly amongst Black, Asian and Minority Ethnic communities and other groups who are currently under-represented within local services;
  - Increasing the numbers of people diagnosed with dementia locally;
  - Continuing to develop support for people affected by dementia including carers before, during and following diagnosis;
  - Developing workforce learning and development initiatives that support improved understanding and support for customers and citizens

#### OTHER OPTIONS CONSIDERED

5.1 Not approving the implementation of the local strategy and action plan would be contrary to national policy directives and local needs.
