Patient-led NHS

The Department of Health has confirmed the following configuration for PCTs in Derbyshire:

- Derby City PCT
- Derbyshire PCT (excluding Glossop).

This will come into effect from 1st October, but the PCTs will obviously be starting to work towards the change immediately.

The three main functions of a Primary Care Trust have also been confirmed as:

- engaging with its local population to improve health and well-being
- commissioning a comprehensive and equitable range of high quality, responsive and efficient services, within allocated resources, across all service sectors and
- directly providing high quality responsive and efficient services where this gives best-value.

Copying Letters to Patients

The PCTs are working to implement the 'copying letters to patients' initiative.

'Copying letters to patients' is a national initiative to improve communications between clinicians and their patients. It involves offering patients a copy of items such as referral letters, as a matter of course. This means the patient is better informed and knows what is being written about them in letters to consultants and other health professionals.

We are encouraging all patients to ask for a copy of such letters, if they think it will be helpful.



Normanton Medical Centre

United Healthcare Europe will soon be starting to provide services at the Normanton Medical Centre. While the contract for these services is being negotiated, we have been providing a full range of medical and associated health care services from the practice.

The appointment of United Healthcare Europe followed the retirement of local GP Dr Paul and a consultation with neighbouring GPs, the Derbyshire Local Medical Committee and the City Council on options to provide a high quality service to the existing patients.

We went out to tender for the provision of medical services and received four tenders from potential suppliers. We undertook a rigorous short listing and selection process and identified a preferred supplier - United Healthcare Europe - on the ability of the company to meet the contract specification.
