## **Corporate Parenting Committee**

#### SUMMARY

- 1.1 Council re-established a standalone Corporate Parenting Committee as part of the changes it made to the scrutiny arrangements in May 2015.
- 1.2 While Corporate Parenting Committee has operated better as a standalone committee rather than as a sub-board of the scrutiny committee responsible for Children and Young People, it is felt the terms of reference detailed in the Scheme of Delegations should be strengthened. This would ensure the work of the committee is better reflected in its definition.
- 1.3 The proposed changes are detailed in the Appendix and put to members to consider for approval.

#### RECOMMENDATION

2.1 To approve amendments to the Scheme of Delegations (Part 3 of the Council Constitution) to strengthen the terms of reference for the Corporate Parenting Committee, as detailed in Appendix 2.

#### REASONS FOR RECOMMENDATION

- 3.1 The existing wording in the Scheme of Delegations is very brief. It is felt that the experience of the last two years, and the establishment of a strong work programme for the committee, has clarified its role and that it would be helpful and appropriate if the Scheme of Delegations reflected this.
- 3.2 In addition, Ofsted recommended, following the Single Improvement Framework inspection in March 2017 that the Terms of Reference be strengthened to reflect the true role and function of the Corporate Parenting Committee.

#### SUPPORTING INFORMATION

4.1 The existing terms of reference amounts to a single sentence, which states:

To consider matters relating to the council's duties in respect of looked after children, including the role of elected members and the authority as a whole as 'Corporate Parents'

4.2 The proposed terms of reference are detailed in Appendix 2. Nothing is proposed to be added which is not reflective of work which is undertaken as part of the existing work programme.
