

Introduction

On 15th November 2019 we launched the consultation on the Licensing Policy Review. The consultation was open for 12 weeks, closing on Monday 10th February 2020.

The Licensing Act 2003 requires Derby City Council to publish a Licensing Policy. The Policy guides elected members of the General Licensing Committee on the boundaries and power of the Council and provides them with the parameters within which to make their Licensing decisions. The Policy informs licence applicants, residents, businesses on the scope the Council uses to make decisions about granting licences. The Policy is reviewed every five years and was last undertaken in 2015.

The consultation was primarily conducted through an online survey with paper versions available at The Council House and on request. Different versions and translations were also available on request. People were also given the opportunity to write in with any other comments they had.

13 people gave their view through the online survey


- 2 via a paper questionnaire

A note on the data in this report: Data from the closed option questions is presented in the report as a % score. The data in the text of the report is rounded up or down to the nearest whole percentage point. Charts or tables therefore may result on occasions adding up to 99% or 101%. If a table or chart does not match exactly to the text in the report this occurs due to the rounding up or down when responses are combined. Results that differ in this way should not have a variance that is any larger than 1%.

When reading the data, please note that there is a base number against all charts and tables; this is the valid number of responses for that particular question and the figure that the percentages are calculated from.

Feedback

Respondents were asked the strength of agreement/disagreement with seven statements. Overall more respondents agreed with the statements than disagreed. The most support came for the statement 'The Policy will help protect local residents' (86.7% combined strongly agree and agree), the two statements that encountered most disagreement were 'The Policy is easy to read' (13.3% disagreed) and 'The Policy is easy to understand' (13.3% disagreed) [Figure 1].



Comments on the wording of the Policy

Five respondents opted to comment on the wording of the policy, comments made were as follows:

The condition relating to pagers and contact with other venues should be made stronger. For example for venues within the city centre NTE it should be mandatory to be part of the Pubwatch scheme and have a fully functioning radio

. The whole thing needs to be more clearly laid out and concise

The whole policy needs reworking into plain English and to remove frequent duplication of information

Points of note Should the name of the department reflect the actual section name to reduce confusion from MOP (Plain English) E.g. Food and Safety Team Environmental Protection Team is currently listed as Pollution Control and Health and Safety 9.12 point five could the wording " and control any" be added after prevent Noise and vibration Point One do we need to add except of access and egress?

I like the council in what they do

General comments and suggestions

Consultees were also given the opportunity to make any broad comments or suggestions on the Licensing Policy as a whole – 5 responded. The themes that emerged from these comments are set out below. They ranged from an assessment of the policy and deemed it to be satisfactory to those that commented that the Policy would be improved were it to be clearer:

Everything is fine

As Team Leader for the responsible authority, I have taken time to consider the changes that reflect my area of responsibility and as such have no comments to make.

It is poorly put together - strive for clear objectives and practical ways to achieve them, in plain English please

It is poorly written and looks like simply a paper exercise

The remaining comment was from a licence holder:

I've been a license holder for long time and is the only source of income I have


Figure 2: General comments and suggestions given

Who took part?

To understand in what capacity responses were made to the survey, consultees were asked to select, from a variety of options, as many as were appropriate. Most of the respondents identified as Derby residents (7) and/or current licence holders (6). The full results are in Chart 1.

Base: * This was a multiple response question where respondents could select more than one answer so responses not reflective of participant number.




Chart 4: Do you consider yourself to be a disabled person?
