Report of the Strategic Director of People

Inspection of Services for Children in Need of Help and Protection, Looked After Children and Care Leavers

SUMMARY

- 1.1 In November 2013 Ofsted commenced inspections against a new inspection framework on local authority services for children in need of help and protection; children looked after and care leavers (the 'SIF' inspection).
- 1.2 To date (7 June 2017) there have been 142 authorities inspected under the framework and as at the end of April 2017 (last publication date) there had been 129 reports published with most authorities being judged as 'requires improvement'...
 - Outstanding authorities 2 (2%).
 - Good authorities 35 (27%).
 - Requires improvement authorities 60 (47%).
 - Inadequate authorities 32 (25%).
- 1.3 The framework assesses authorities against three key judgements areas with two sub-judgements under one element of the framework, all of which contribute to an 'overall effectiveness judgement'**...
 - The experiences and progress of children who need help and protection.
 - The experiences and progress of children looked after and achieving permanence.
 - Adoption performance.
 - The experiences and progress of care leavers.
 - Leadership, management and governance.
- 1.4 Derby City was inspected, by Ofsted, under this Framework in April 2017 and Derby's final report is scheduled to be published on the <u>Ofsted website</u> on Tuesday 13 June 2017.
- 1.5 Andy Smith –Strategic Director for People Services and Sarah Walker Policy and Improvement Manager will attend the meeting to give Members a presentation on the outcomes of Derby's inspection.

RECOMMENDATIONS

- 2.1 To note the current position with regards to the SIF inspection programme, as set out in paragraph 1.2.
- 2.2 To receive the presentation at the meeting on Derby's inspection outcomes; paying particular attention to the recommendations for improvement.

REASON FOR RECOMMENDATIONS

3.1 It was agreed at the Mocksted Performance Surgery in November 2016 that an update would be presented to Inspiring Young People Board, in April 2017, on further progress made in priority areas. The inspection outcomes address this recommendation and sets out clear recommendations for improvement priorities going forward.

SUPPORTING INFORMATION

4.1 Inspiring Young People's Board have previously received a number of updates on the SIF framework including; national outcomes and progress in local inspections readiness (April 2014, October 2014, September 2015 and December 2016). Further to this, the Chair hosted a Performance Surgery on assessing progress from the locally run 'mocksted' inspection in November 2016.
