The Mayor invited the Monitoring Officer to address the meeting, who informed councillors that a general dispensation had been granted to allow voting to take place on the Council Tax proposals and the Councillors' Allowances Scheme for 2022-23.

92/21 Announcements from the Mayor

The Mayor reflected on the outbreak of war in Ukraine. The Mayor reported that they had recently attended a memorial service with members of the Ukrainian community in Derby, together with local Members of Parliament, members of the Council and other civic dignitaries.

It was reported that under the provisions of Council Procedure Rule CP42r, the Mayor had agreed to accept a late item on grounds of urgency, relating to the situation in Ukraine, and that the matter would be considered following the conclusion of the other business listed on the agenda.

The Mayor placed on record their thanks to Derby City Council employees who had responded to Storms Dudley, Eunice and Franklin, noting that effective emergency

planning had protected Derby from the most severe effects of storm damage and flooding.

Several procedural matters were reported, relating to the consideration of the Medium Term Financial Plan and Council Tax proposals. The Mayor stated that they intended to exercise discretion under Council Procedure Rule CP46 to vary the amount of time opposition spokespeople had to respond to the budget proposals.

It was reported that two serving councillors would be standing down ahead of the local elections due to take place on Thursday 4 May 2022. Tributes were paid to Councillors Bettany and Willoughby in recognition of their time serving on the Council.

The Mayor also reported to Council the passing of Sir Alan Jones, former Managing Director and Chairman Emeritus of Toyota UK, who had been closely involved with the opening and operation of Toyota's Burnaston plant. Councillor Ingall offered their recollections of working with Sir Alan.

A moment's silence was then observed in respect of the situation in Ukraine and the passing of Sir Alan Jones.

The revised report set out the total Council Tax for Derby residents for 2022/23, and included precepts for the Derbyshire Police and Crime Commissioner and Derbyshire Fire Authority.

102/21 Pay Policy Statement 2022/23

103/21 Councillors' Allowances Scheme 2022/23

A report of the Strategic Director of Corporate Resources proposing a Councillors' Allowances Scheme for 2022-23 was presented to Council. The report noted that in setting a scheme of allowances, Council must have regard to the recommendations of an Independent Remuneration Panel (IRP).

It was noted that a report of the IRP had last been considered in July 2021, when Council had accepted wholesale the recommendations from the IRP and adopted a revised scheme of allowances.

The report proposed a scheme that made only consequential amendments to the previous version. In July 2021, Council agreed to index link both the Basic Allowance and the Special Responsibility Allowances to the Local Government Pay Award for a period of four years. The report recommended that responsibility was delegated to the Strategic Director of Corporate Resources to apply the award once it was agreed nationally.

It was moved by Councillor Barker and seconded by Councillor Potter that the recommendations in the report be approved. The recommendations were put to the vote and carried.

105/21 Urgent Non-Executive Decisions made by the Chief Executive

A report of the Chief Executive was considered, reporting to Council urgent non-executive decisions taken under delegated authority, following consultation with political group leaders, since the last meeting of Council.

The report detailed a decision to approve the Council's application for membership of Infinity Park Derby Management Ltd, a property management company responsible for the management, maintenance and improvement of common areas of Infinity Park, Derby. The Council's purchase of part of Infinity Park as part of the NAMRC Midlands scheme had triggered a requirement to become members of the management company. An urgent decision had been needed prior to the January meeting of Council, as transactional documents were required to be completed by 17 January 2022.

It was moved by Councillor Barker and seconded by Councillor Potter that the recommendations be agreed. The matter was put to the vote and carried.

Resolved to note the decision of the Chief Executive, following consultation with the political group leaders, to approve the Council's application for membership of Infinity Park Derby Management Ltd.

106/21 Local Government Boundary Review – warding pattern submission

Council received a report of the Strategic Director of Corporate Resources proposing a draft warding pattern submission to the Local Government Boundary Commission for England's (LGBCE) review of Derby City Council.

It was reported that the LGBCE had been undertaking a review since July 2021 and had previously recommended that the Council retain 51 councillors. The next stage of the review was to establish a warding pattern for the Council's area, based on the following statutory criteria:

- Delivering electoral equality for local voters

- Protecting the interests and identifies of local communities
- Ensuring effective and convenient local government

It was noted that a public consultation was running between 26 October 2021 and 29 March 2022, and that the Council had been invited to submit a response, alongside other local stakeholders. The report detailed the methodology and process followed to develop a warding pattern in consultation with councillors that was consistent with the three statutory criteria.

A proposed warding pattern was attached at Appendix 1 to the report, alongside data relating to the estimated size of Derby's electorate by 2027 and projected housing growth across the city for the same period.

The report summarised feedback received as part of several workshops held with ward councillors. It also noted strong preference for the retention of seventeen wards containing three councillors each, and ensuring ward boundaries remained co-terminus with Parliamentary constituencies.

It was moved by Councillor Barker and seconded by Councillor Poulter that the recommendations in the report were approved. The recommendations were put to the vote and carried.

Resolved:

- 1. To approve the draft warding pattern submission attached at Appendix 1 of the report for submission to the Local Government Boundary Commission for England.**
- 2. To agree that the Council favours a uniform warding pattern, comprising of seventeen wards, containing three councillors per ward, and to request that the LGBCE considers the arguments presented at paragraph 4.18 of the report in developing its recommendations.**
- 3. To request that the LGBCE considers the arguments in favour of respecting Parliamentary boundaries, as detailed at paragraphs 4.20 to 4.23 of the report.**

107/21 Motion: Solidarity with Ukraine
