115/05 Proposal to change the structure of Overview and Scrutiny Commissions

This item was considered in conjunction with the late item regarding the future role of the Corporate Parenting Sub Commission. The Commission considered a report of the Chair containing a proposal to reduce the number of Overview and Scrutiny Commissions from six to five, together with a report of the Corporate Parenting Sub Commission on the value of retaining that Sub Commission as a separate body.

Councillor Latham expressed her concern that a similar proposal had been made in 2005 and had been rejected at the Annual Meeting. She was also concerned that the proposal had been made just before the election.

Councillor Jones felt that a system that enabled as many back benchers as possible to be involved in Overview and Scrutiny was preferable. She circulated a paper to illustrate.

Steve Dunning, Assistant Director - Democratic Services outlined the rules regarding political representation on Commissions.

Councillor MacDonald emphasised the need for a Corporate Parenting Sub Commission and Councillor Allen felt that it was important that this Sub Commission be formally written into the Commission structure.

The Chair explained that the aim of the proposed structure outlined in the report was to bring the Commission's broadly in line with the Cabinet Member portfolios. He felt that there should be a process of ongoing review of Overview and Scrutiny arrangements.

Concern was raised about maintaining the interest of co-opted Members and about their voting rights under the proposed structure.

Resolved to recommend that Council:

- 1. Accept the five Commission structure set out in paragraph 2.4 and 2.5 of the report, but to include a Corporate Parenting Sub Commission in the structure
- 2. Increase the membership of each Commission to 10 members

32/05 Proposal to the Casino Advisory Panel

The Committee considered a report that set out details of a proposal submitted to the Casino Advisory Panel for permission to locate a large casino in Derby.

The Casino Advisory Panel is an independent panel that was established in September 2005 to advise the Government on the geographical areas in which the new types of casino created by the Gambling Act 2005 would be located. One regional casino, eight large and eight small casinos would be permitted. 41 local authorities had applied for a large casino.

On 31 January 2006, the Panel invited formal applications from local authorities who wanted to have a new casino in their area. Proposals needed to reach the Panel by 31 March 2006. Derby Cityscape submitted a provisional application, on behalf of the Council, subject to the final decision being made by the General Licensing Committee.

David Marshall the Director of Development at Derby Cityscape considered that the application had been supported by Derby City Partnership and the Strategic Partnership for Derby and Derbyshire. It was reported that the proposal had been endorsed by the Strategic Partnership in February 2006 and the Derby City Partnership in March 2006.

Work on the bid had been completed in conjunction with 'Tribal' consultants. Tribal had advised of a minimum of 250 extra jobs and a catalyst for other opportunities, such as a hotel and conferencing facilities.

Councillor Skelton asked why a casino was necessary when Gala Bingo had just received a new licence. David Marshall responded that the casino proposal was for 40,000 sq ft, whereas Gala Bingo was 25,000sq ft.

Councillor Allen considered that there had not been sufficient consultation, especially as many Councillors hadn't seen the proposal prior to the meeting. He also considered that Tribals' report did not focus on the social impact of the casino. John Tomlinson responded that the application only reached the

licensing team three days before the application deadline and therefore did not leave enough time to consult the Committee on the proposal before submission.

Resolved

- 1. to note the Casino Advisory Panel's role in the establishment for new types of casinos and the procedure involved in selecting locations for their operation
- 2. to recommend to Council that it supports the application to locate a large casino in Derby.
- 3. to ask officers to include in the report to Council information on the negative aspects of gambling.

Councillors Allen and Skelton requested that her vote against the decision be recorded.
