Walk in Centre

Work started on the new Walk-in Centre at the end of June when the PCTs, Derby Hospital and GF Tomlinson Building Ltd met to turn the first sod for the new building.

NHS Walk-in Centres are designed to provide quick access to advice and treatment for minor ailments. Derby's Walk-in Centre will be located at the junction of Osmaston Road and Litchurch Street – on the Derbyshire Royal Infirmary site.



The Walk-in Centre will offer healthcare information and treatment for:

- coughs and colds
- minor cuts and bruises
- skin complaints
- men's and women's health problems
- those needing emergency contraception.

It will also offer information around health promotion, healthy eating, smoking cessation and sexual health and will be a base for other services such as Citizens Advice Bureau, Social Services, Out of Hours Service and Pharmacy Services.

The new centre is due to open in April 2007.

Department of Health Consultations

The Department of Health has recently announced two consultations relating to smoking.

The smoke free premises and vehicles consultation outlines proposals for regulations to be made under Chapter 1 of Part 1 of the Health Bill. The consultation document asks questions on issues where the Department would like feedback and they welcome other comments on any aspect of the proposals. The closing date for responses is Monday 9 October 2006.

The other consultation is on the under age sale of tobacco. This consultation invites views on:

- changing the minimum age for sale of tobacco
- sanctions against retailers for breaking the law.

The Department would also welcome suggestions on any other measures that might help to reduce smoking among young people.

The closing date for this consultation is Monday 2 October 2006.
