# **Street Cleansing Bins**

## Purpose

1.1 Scrutiny have asked for a report on the City Centre rubbish bin emptying collection programme and associated costs.

## **Supporting information**

- 4.1 The litter bins within the City Centre are emptied by the 2 teams that clean the area; they are emptied multiple times a day as required whilst the team is carrying out litter picking duties.
- 4.2 City Centre Early shift

8 FTE's working on a rota to cover 7 days a week from 4am–12pm (generally 4/5 staff per day Monday to Friday and 5/6 Saturday and Sunday). The cost of this team is £197k (this does not include holiday and sickness cover). This team clean the City Centre following the night time economy; they are responsible for ensuring that the City Centre is Grade A by 8am. They start off in the Centre of the City and then move out to the outer areas such as Midland Road, Friar Gate etc. This team will utilise footway sweepers at weekends with the higher staff level.

4.3 City Centre Dayshift

7 FTE's working on a rota to cover 7 days a week, 10am-6pm Monday to Saturday and 8am-4pm on a Sunday (generally 4/5 staff per day Monday to Friday and 5 Saturday and Sunday). The cost of this team is £172k (this does not include holiday and sickness cover). This team are responsible for ensuring the City Centre remains clean throughout the day. They will concentrate on the areas of main footfall and then move to the outer areas when possible such as Midland Road and Friar Gate etc. 4.4 Additional to this we also have the following activities within the City Centre

Car park Cleaning

1 FTE (2 PT staff) that work Monday to Friday 6am-2pm (we also clean the 3 multistorey carparks on a Saturday but this is picked up by the other City Centre team).

Chewing Gum removal

1 FTE working Monday to Friday 4am – 12pm removing chewing gum and carrying out jet washing, predominately within the City Centre.
