### Context

#### Derby's last judgement inspection was in March 2017

## **ILACS** background

- Part of a 'whole-system approach' to inspections
- Authorities can be assessed via a short or standard inspection (based on last inspection outcome)
- Inspections focus on the effectiveness of local authority services and arrangements in relation to:
  - how our practice helps and protects children;
  - the experiences and progress of children in care wherever they live, including those children who return home;
  - our arrangements for permanence for children who are looked after, including adoption; and
  - the experiences and progress of care leavers.



# What did inspectors do?

- Met with the Lead Cabinet Member, Chief Executive, Independent Chair of Derby and Derbyshire Safeguarding Children Partnership and the Strategic Director of People Services (Director of Children's Services, DCS)
- Assessed 275 different pieces of evidence before arriving onsite, with a further 30 pieces considered during the inspection fieldwork
- Reviewed the experiences of 12 children and young people, where previous quality assurance activities had been completed in the last 6 months by the local authority
- **Spoke with over 50 of our colleagues**, directly sampling children and young people's experiences, with visits to IDCS and the Leaving Care Service
- **Observed** a Section 47 Strategy Meeting
- Met with six members of our Children in Care Council
- Talked to four foster carers and four adopters
- Spoke to four Designated Teachers in schools within and outside of the city
- Heard about the experiences of many of our care leavers, including speaking directly to six young people

# **Key highlights**

### **Help & protection**

- Timely and appropriate response to contacts and referrals
- Thresholds consistently and appropriately applied
- Limited drift and delay, through good quality assessments, direct work and plans
- Effective monitoring of CME and EHE
- Quality return interviews, PF and 16/17 homelessness processes have improved
- Partnership working is effective
- CYP voices effectively captured
- PLO processes effective
- Services for disabled CYP

### Children in care & care leavers

- Only looked after if in CYP best interests
- CYP engaged, feel listened to and workers know them well
- SMART plans
- Strong IRO footprint
- Stable placements where risks are proactively managed
- Contact promoted
- Sensitive and appropriate support for all CIC (inc. UASC)
- Strong Virtual School
- Good fostering assessments with appropriate scrutiny
- Care leavers supported to positive outcomes by passionate PAs

#### **Impact of leaders**

- Passionate and loyal workers
- All SIF, JTAI and FV recommendations acted on
- DCC is self-aware and leaders are connected to practice
- Strong corporate support and Corporate Parenting Board
- CYP are at the centre of work and influence decisions
- Senior management/leaders are visible, accessible and valued
- Robust partnerships
- Regular, reflective supervision
- Strength based model of practice embedded and is consistently applied
