Committee on Standards in Public Life 'Setting the Standard"

SUMMARY

- 1.1 Attached at Appendix 2 of the report is a letter from Lord Bew, Chair of the Committee on Standards in Public Life. Attached at Appendix 3 of the report is a copy of 'Setting the Standard', which was published yesterday and includes the Committee's annual report for 2017- 18, forward plan for 2017-18, and strategic plan. It may be of particular interest to note that the Committee has confirmed its intention to undertake a review of local government standards as part of its 2017/18 work programme:
 - "The Committee maintains a longstanding interest in local government standards, and regularly receives correspondence from members of the public expressing their concern about this issue. We were actively conducting research and engaging with partners on this subject throughout 2016-17, and we intend to undertake a review of local government standards during 2017-18.
- 1.2 This review will be based around a consultation that will be launched in early 2018. Based on the submissions to this review and meetings with key stakeholders, we intend to publish our findings and recommendations in 2018."
- 1.3 There is due to be a full review of Derby City Council's standards regime in the near future and the Committee's consideration of the attached report should help inform this.
