## **ITEM 10**

#### **Anchor Institutions in Derby and Derbyshire**

#### **Purpose**

1.1 To update Cabinet on local work regarding Anchor Institutions across Derby and Derbyshire and ask Cabinet to agree that Derby City Council be a signatory to the Anchor Charter (attached as Appendix 1).

#### Recommendation(s)

2.1 To agree that Derby City Council becomes a signatory to the Derby and Derbyshire Anchor Charter.

#### Reason(s)

3.1 By becoming a signatory to the Derby and Derbyshire Anchor Charter the Council can draw on the collective influence of other Anchor Institutions to build community wealth and develop resilient, inclusive local communities.

#### **Supporting information**

- 4.1 The Health Foundation defines an Anchor Institution as:

  "An institution that, alongside its main function, plays a significant and recognised role in a locality by making a strategic contribution to the local economy." Anchor institutions are so called because they are effectively anchored in their local communities and are unlikely to relocate. They have sizeable assets that can be used to build wealth in and develop their local community through procurement and spending power; workforce and training; and buildings and land.
- 4.2 Key areas where Anchor Institutions have an impact include:
  - Employment: Widening access to work.
  - Partnering in place: Across organisations and the voluntary and community sector.
  - Procurement: Purchasing more locally and for social benefit.
  - Buildings: Using buildings and spaces to help communities.
  - Environment: Reducing environmental impact.

- 4.3 The Derbyshire and Derby Anchor Institutions work is being led by Joined Up Care Derbyshire with an Anchor Executive Group jointly chaired by the Strategic Director of People Services at the city council and the Chief Executive of Derbyshire Healthcare NHS Foundation Trust. Membership includes both the city and county councils, all health partners, Rolls Royce, Derby University and Derby County Community Trust.
- 4.4 For the first time in Derby, all the major anchor institutions have been working together on agreeing a set of strategic priorities. An 'Anchor Charter' has been developed to secure commitment from individual organisations and provide a framework to make the agreed changes that will benefit communities across Derbyshire and Derby. Each anchor organisation agreed to take the Anchor Charter through their internal governance processes to get sign up.
- 4.5 The initial strategic focus locally of the Anchor Institutions approach is workforce and employability, including supporting those who are the furthest away from work. Each Anchor Institution has undertaken a 'stocktake' on what is currently delivered and supported in relation to employability and workforce. The stocktake has provided all partners with an overview of good practice, opportunities for sharing and/or scalability and identification of system gaps.

#### Public/stakeholder engagement

5.1 The anchor approach and development of an Anchor Charter has been fully endorsed and supported by the City Partnership Board.

#### Other options

6.1 Do nothing. Derby City Council do not sign the Anchor Charter and cease to be a member of the Anchor Executive Group. Were the Council not to sign the Anchor Charter, and cease its membership in the group, it would lose the opportunity to influence the work of Anchor Institutions across the city and the associated benefits for residents.
