Dear Charlotte

Re: Consolidation onto the site at 18-20 Sinfin District Centre, Sinfin, Derby DE24 3ND of B. J. Wilson Ltd already at that site and B. J. Wilson Ltd currently at 430 Stenson Road, Derby DE23 1LH.

It is the representation of Derby City Health and Wellbeing Board that the consolidation of the two sites referenced above **will not** create a gap in pharmaceutical services that could be met by a routine application (a) to meet a current or future need for pharmaceutical services, or (b) to secure improvements, or better access, to pharmaceutical services.

This representation is based upon:

- 1) The Derbyshire County and Derby City Pharmaceutical Needs Assessment (PNA) 2018-2021 - Statement of Pharmaceutical Need for Derby City (<https://www.derby.gov.uk/media/derbycitycouncil/contentassets/documents/adultsocialcare/jointstrategicneedsassessment/derbycitycouncil-pharmaceutical-needs-assessment-2018.pdf>) and supplementary statements.
- 2) Consideration of the proposed consolidation in terms of:
 - Change in pharmacies/ 100,000 population.
 - Changes in access and availability.
 - Whether the change/closure will still provide sufficient choice of providers in the locality.
 - Changes to the current service provision.
 - Changes to provision of specialist services or equipment.
 - Any future proposals e.g. housing developments that could be impacted by the proposed consolidations.



Councillors of the ward affected; NHS and local authority commissioners of
community pharmacy services.

The Health and Wellbeing Board would, however, like to note that if the application to consolidate onto the site at Sinfin District Centre is granted, it will mean that the resident population of Sunny Hill will have to travel further for face-to-face community pharmacy services. Face-to-face demand at the closing (Stenson Road) site is, however, thought to be relatively low and it is believed that many of those who access the closing pharmacy already use the pharmacy at Sinfin District Centre. The population of the affected area will still be within one mile of the proposed consolidated site as well as four other pharmacies.
