# Preparing for an inspection of services for children and young people with special educational needs and / or disabilities (SEND)

## SUMMARY

- 1.1 Ofsted and the Care Quality Commission (CQC) commenced local area inspections of services for children and young people with special educational needs and / or disabilities (SEND) in May 2016.
- 1.2 The aim of the inspection is to answer three key questions...
  - 1. How effectively does the local area identify children and young people who have special educational needs and/or disabilities?
  - 2. How effectively does the local area assess and meet the needs of children and young people who have special educational needs and/or disabilities?
  - 3. How effectively does the local area improve outcomes for children and young people who have special educational needs and/or disabilities?
- 1.3 All local areas will be inspected at least once during a five year period, from May 2016 onwards. To date there have been 39 inspection letters published, with four inspections in the East Midlands region; Nottinghamshire, Northamptonshire, Rutland and Derbyshire.
- 1.4 Andy Smith, Strategic Director for People Services and Hazel Lymbery, Service Director for Early Help and Children's Safeguarding will attend the meeting to present Members of the Board with an update on Derby City's current strengths and areas for improvement, in line with the inspection framework.

# RECOMMENDATIONS

- 2.1 To note the key elements of the SEND inspection presented in paragraphs 4.4 to 4.7.
- 2.2 To receive the presentation at the meeting on Derby's current self assessment.

# **REASON FOR RECOMMENDATIONS**

3.1 Ofsted and CQC are inspecting all local authority areas under the framework. Making sure that staff and members are briefed on the requirements of the framework and current strengths and areas of risk are critical to making sure that a 'good' outcome

can be achieved.

### SUPPORTING INFORMATION

- 4.1 The 2014 Children and Families Act and the subsequent 2014 Special Educational Need and Disabilities (SEND) Code of Practice introduced new statutory duties and expectations for local areas from 1 September 2014. The reforms aimed to offer consistent and simpler help for disabled children and young people and their families / carers from birth through to the age of 25 years.
- 4.2 The reforms have had far reaching implications for a number of stakeholders in Derby including health, local authorities (children's social care, adult and education), education providers such as early years, schools, further and higher education institutions and the voluntary and community sector.
- 4.3 Following the introduction of the reforms Ofsted and the Care Quality Commission (CQC) consulted formally on proposals for inspecting how effectively local areas fulfil their responsibilities to children and young people who have special educational needs and / or disabilities (SEND). The results of this consultation shaped the new joint CQC and Ofsted inspections of SEND, published in April 2016 with inspections commencing in May 2016.
- 4.4 A key feature of the SEND inspection is that it is assessing the local area rather than a single agency. All areas will be inspected once during a five year cycle and inspections will last for five working days (with five working days notification time). Inspections will entail a mixture of individual case tracking, interviews, focus groups and visits to schools and other settings across an area.

- 4.5 A standard inspection team will consist of three inspectors (HMI's) who will pay attention, to a number of key issues...
  - The accuracy and rigour of the local area's self-evaluation the extent to which the local area knows its strengths and weaknesses, and what it needs to do further to improve the life chances of children and young people with special educational needs and / or disabilities.
  - The extent to which outcomes for children and young people are improving as a result of the collective actions and support of local agencies and bodies.
  - Efficiency in the identification of special educational needs and / or disabilities.
  - The timeliness and usefulness of assessments.
  - How well local agencies and bodies plan and coordinate their work to assess need, providing necessary and effective support.
  - How well the local area engages with children and young people and their parents and carers, to inform decisions about the strategic commissioning of services, using the Joint Strategic Needs Assessment or JSNA.
  - How well the local area involves the individual child or young person and their parents and carers in the process of assessing their needs.
  - How well the local area communicates with children and young people and their parents or carers to ensure that these primary users are clear about the identification and assessment processes and the criteria used to make decisions.
  - The extent to which the local area gives due regard to its duties under the Equality Act 2010 to children and young people with special educational needs and / or disabilities.
  - How the local area uses the intelligence gathered from evaluations of its effectiveness to plan for and lead future improvement.
- 4.6 The starting point for the inspection is the expectation that the local area should have a good understanding of how effective it is, including any aspects of its responsibilities that require further development. Inspectors will test out this understanding during the inspection, as they make their evaluations. The accuracy and rigour of Derby's selfassessment is therefore of critical importance.
- 4.7 Following an inspection, local areas will receive an inspection letter that will set out the findings of the inspection. If there are serious concerns about local area arrangements there will be a request made for a 'Written Statement of Proposed Action'. This must be completed within 70 working days of the publication of the inspection letter.
