Having carefully reviewed these it is disappointing that a number of complaints are made by one Councillor against another. This is a behaviour which, I believe, undermines the genuine willingness of the majority of Councillors who are keen to act in the best way possible to deliver good outcomes for Derby residents.

As is demonstrated by this Annual Report, the majority of complaints were dismissed. Of those upheld, I would like to take this opportunity to say that compliance with the sanctions of the Standards Committee should be acted upon, thus further evidencing the promotion of good ethical governance.

Also, it is disappointing that complaints are virtually guaranteed after each Full Council meeting. I feel that we should be capable of conducting business without these having to be submitted.

I would like to thank the support and dedication of our Independent Persons and Co-opted Members and my fellow Councillors for their valuable input and contribution to the work of the committee throughout the year.

The Standards Committee promotes and maintains the high standards of conduct among Derby City Council's 51 Elected Members and co-opted members.

The Standards Committee role is to:

- play a vital role in promoting and maintaining high standards of conduct by Council Members;
- add to the feeling of ethical well-being in the Authority;
- give the public extra confidence that representatives are acting honourably in accordance with the principles of public life; and
- underpin trust and confidence in local democracy.

The Standards Committee is responsible for the following activities:

- assisting the Elected and Co-opted Members to observe the Members' Code of Conduct;
- advising on and monitoring the operation of the Members' Code of Conduct;
- determining complaints referred by the Monitoring Officer; and
- ensuring Elected and Co-opted Members receive training and advice on matters relating to the Members' Code of Conduct.

# **The Monitoring Officer and Officer Support**

Councils have a statutory duty to appoint a Monitoring Officer to ensure the lawfulness and fairness of Council decision making. The Monitoring Officer effectively serves as the guardian of the Council's Constitution and the decision making process. The Monitoring Officer works closely with the Standards Committee to assist it in its role of promoting and maintaining high standards of conduct.

Derby City Council's Monitoring Officer for 2016/17 is the Director of Governance, Janie Berry. Janie works closely with Steven Mason, Democratic Services Officer, to support all Members of the Standards Committee and to ensure fairness and consistency in the progression of Code of Conduct related complaints.

# **Consideration of Complaints**

As I referred to earlier, there has been a high volume of Code of Conduct related complaints received during the 2016/17 municipal year.

16 complaints were received during 2016/17 and four complaints were carried over from the 2015/16 municipal year

There have also been six informal complaints which have required preliminary consideration by the Monitoring Officer. However, none of these proceeded to formal complaints.

#### Formal Complaints considered

Of the 20 complaints considered, three of these were upheld and 13 were rejected. Four complaints have been carried over to the 2017/18 municipal year.

The Standards Committee sat as a Hearing Panel on 31st January 2017.

# **Report in the Public Interest Related Complaints**

On 16th June 2016, Grant Thornton, the Council's External Auditors for the financial years including 2013/14 and 2014/15, published a Report in the Public Interest.

The Report in the Public Interest reported on a number of governance related issues, most of which were historical in nature.

Twelve recommendations were proposed in the report and on 1st July 2016, the Administration placed an Action Plan before Full Council responding to these. The Audit and Accounts Committee is responsible for oversight and progress of the Action Plan.

A number of complaints, into allegations concerning Elected Members', were received that were connected to this report.

Eight complaints, in total, were considered by Wilkin Chapman LLP, appointed by the Monitoring Officer. Two of these were rejected and the remaining six were investigated. Of those investigated, no breach of the Code of Conduct was found for four and two have been carried over to the 2017/18 municipal year.

A review of the Council's Standards Regime is on hold, pending the outcome of the remaining two complaints.

# Referrals to the Monitoring Officer Relating to Taxi Licensing Issues

Any instances of Member interference with Taxi Licensing are recorded and reported to the Monitoring Officer.

On a quarterly basis, the Monitoring Officer reviews the records, or sooner if the circumstances as they present require earlier intervention.

The Report in the Public Interest issued by Grant Thornton expressed concerns about the Taxi Licensing function operated by the Council. The resultant Action Plan makes reference to instances of Member interference in taxi licensing being reported to the Standards Committee.

In order to provide additional oversight, the Monitoring Officer reports the instances which have required her intervention, to the Standards Committee for awareness raising and consideration and comment as necessary.

The first of these reports was presented to a meeting of the Standards Committee on 19th July 2016.
