2. How do we encourage more young people aged 18 to 25 to vote?	
Social Media – reminders to vote, promotes voting as something for younger people too	Online voting – time to go/remembering a postal vote, can you do secure email? Or texts, don't have to count votes, ID verification or a postal vote is not very secure anyway
Text idea – update changing details if you have a new number, could have a code to login to a secured website	Lower voting age to 16 in local council
Teach or discuss more in schools so that people are more well informed from a younger age	More polling stations in universities etc
Let them know their vote matters	Teach them the effect they have on politics
More enterprise days about politics at school	Make politics less boring

Dangerous, Sam could be in danger from knives or guns.	The other person is a stranger 'Stranger Danger' he might want money or he might hurt Sam. Taking drugs is bad for you and dangerous. Sam should tell the police. Sam should tell his teacher or staff they trust in class.
I would tell my keyworker, because key workers keep you safe	

Case Study 2 - Rahib	
1. Are there any concerns	
Forced Marriage	Against his will
Might not have told him	At risk of being estranged from family
May be big part of culture/family	May have a lot of pressure from family members
Concerning that he is being taken out of country/less access to help	May not know where he's going – recorded as missing
Short space of time to intervene	He may fell scared and pressured
Does he know he might be being exploited	The s/o hasn't consented either
Might lead to other mental difficulties – feel silenced/trapped	He thinks this process is normal
If he's too later to gain help	The victim may be neglected/hurt by their family
If the victim has a disability, makes them more vulnerable	If he things it's an arranged marriage – misconception of arranged marriage and forced marriage
Does he know the details of the marriage	The S/O hasn't consented either

2. What type of exploitation might this be?	
Forced marriage	Physical and mental abuse
Sexual	Trafficking potentially
Honour based abuse	Modern slavery
Lack of education	Extremism (extreme behaviour)

3. What support and services might Rahib need to help with this?	
Support at school (unauthorised absence)	Childline and other hotlines
