## Schools Capital Programme 2022/23

#### Purpose

- 1.1 The Council has received notification from the Department for Education (DfE) of school condition maintenance allocations for 2022-23 for Community and Foundation schools.
- 1.2 In order to commence scheme development, and to complete essential work during the school summer holiday period, early approval of schemes is necessary. It is therefore proposed to seek scheme approval for schemes in line with the notified allocation of £3,163,425.
- 1.3 A breakdown of the indicative school maintenance Capital Programme funding for 2022/23 is set out within Appendix 1. The proposed phase 1 schools capital programme schemes for 2022/23, including proposed individual school condition maintenance projects, are outlined in Appendix 2.
- 1.4 The proposal is for funding to be prioritised to deal with essential school condition and maintenance issues across the schools estate for Council maintained schools. An on-going programme of work is required in school premises to deal with essential condition and health and safety issues to ensure that school buildings remain safe and open.
- 1.5 This report seeks Council Cabinet approval for the schools maintenance capital programme for 2022/23 as set out within Appendix 2.
- 1.6 It is also necessary to update the capital programme with the addition of £7,084,154 following the completion of a s106 agreement for the provision of a new primary school to serve new housing as part of the Snelsmoor Grange, Boulton Moor, housing development, and seek scheme commencement approval. Approval is also sought to add a further £502,800 s106 to the capital programme from the Buttercup Leys housing development and seek scheme commencement for works at Noel-Baker Academy.
- 1.7 The report also seeks to update the previously approved necessary delegated authority in relation to the property transactions required for the approved capital programme scheme to expand Landau Forte College Derby.

#### Recommendations

- 2.1 To approve the Schools Capital Programme priority schemes for 2022/23 as outlined in Appendix 2.
- 2.2 To approve scheme commencement of schemes outlined in Appendix 2.
- 2.3 To approve the amendment of the approved 2022/2023-2023/24 capital programme with the revised budget projections detailed in Appendix 1 and the proposed scheme allocations detailed in Appendix 2.
- 2.4 To approve the addition to the capital programme of the £7,084,154 s106 funding contribution and approve scheme commencement, for the construction of the new primary school to serve the Snelsmoor Grange, Boulton Moor housing development, as set out in paragraph 4.7 to 4.9 and Appendix 2.
- 2.5 To approve the addition to the capital programme of the £502,800 Buttercup Leys Secondary education s106 funding contribution, and approve scheme commencement and the award of a grant agreement of up to £502,800 to L.E.A.D. Academy Trust for the proposed scheme at Noel-Baker Academy, as set out in paragraph 4.10 to 4.11 and Appendix 2.
- 2.6 To delegate authority to the Strategic Director of Corporate Resources, in consultation with the Director of Children's Integrated Commissioning, to complete the site acquisitions and subsequent site disposals / transfers, in relation to the previously approved capital programme scheme to expand Landau Forte College Derby, including any necessary additional grant to Landau Forte Charitable Trust, as set out in paragraph 4.12 to 4.14 which may be necessary to ensure successful delivery of the scheme.

#### Reasons

- 3.1 An on-going programme of work is required in school premises to deal with essential condition and health and safety issues across the schools estate to ensure that school buildings remain safe and open. In order to complete as much work as possible during the school summer holiday period, early approval of schemes is necessary.
- 3.2 In accordance with Financial Procedure Rules, amendments to the Council's capital programme are required to be reported to Cabinet.

#### **Supporting information**

4.1 Capital investment across the schools estate in Derby is essential to address maintenance and condition issues. There remains a significant backlog of condition issues across the schools estate, which is in excess of £17m for priority works. This condition backlog only covers building condition issues and excludes costs associated with betterment (unless required under Building Regulations), asbestos identification/removal, work identified as a result of fire risk assessments or any water hygiene remedial work.

#### 4.2 Schools Maintenance Capital Programme

The Department for Education (DfE) have confirmed Derby will be allocated £3,163,425 in School Condition Allocation funding for Community and Foundation schools for 2022/23.

- 4.3 In order to commence scheme development, and to complete essential work during the school summer holiday period, early approval of schemes is necessary. A breakdown of Schools Capital Programme Funding for 2022/23 is set out within Appendix 1.
- 4.4 School capital projects for 2022/23 have been prioritised for those schools with the highest level of need, to ensure that buildings are safe by addressing priority health and safety works. The priority condition schemes for 2022/23 primarily fall into the following four categories:
  - Mechanical projects (heating replacements);
  - Roof works;
  - Window replacement works;
  - External works;
  - Fire precaution work.

The proposed priority school condition projects for 2022/23 are shown in Appendix 2, including details of the proposed work and budget estimates. These indicative budget estimates are subject to a detailed feasibility, design development and procurement process.

4.5 There are a range of projects proposed within the Schools Capital Programme 2022/23, detailed in Appendix 2, to address high priority maintenance and condition issues across the schools estate.

#### 4.6 Schools Devolved Formula Capital

The DfE have also confirmed school Devolved Formula Capital funding allocations for individual schools. This funding is to be used by schools on maintenance and condition projects. This is a small funding stream based on a formulaic allocation of  $\pounds4,000$  per school, and a small per pupil element. Schools prioritise this funding in line with their School Asset Management Plan.

#### 4.7 Snelsmoor Grange, Boulton Moor, New Primary School

The Council has now successfully completed a s106 agreement for a new housing development at Snelsmoor Grange, Boulton Moor, which is made up of 800 dwellings. It is anticipated that 224 primary school pupils will be generated by a development of this size. In addition, a housing development on Fellow Lands Way, Chellaston, made up of 190 dwellings, has recently been completed. Based on the Council's pupil yield multipliers, the total of 990 new dwellings across the two developments will generate an estimated 277 primary aged pupils.

- 4.8 Following careful consideration, as a result of the new housing at Snelsmoor Grange and Fellow Lands Way, a new one and a half form entry primary school (315 pupils), with a 39 place nursery, is proposed to ensure sufficient school places. A school site has been identified within the Snelsmoor Grange housing development and it is anticipated that construction work on the new primary school will commence in Summer 2022 for a September 2023 opening. The proposal is for the new school to open up on a gradual basis, as the new housing is built and occupied. Following previous Council Cabinet approval, the Council is now inviting proposals from Academy Trusts who are able to deliver high quality education and establish the primary school ready for the proposed opening in September 2023.
- 4.9 It is now necessary to update the Council's capital programme to add the new additional Snelsmoor Grange Primary school s106 funding of £7,084,154, as set out in paragraphs 7.4 and 7.5, and Appendix 2, and obtain approval for scheme commencement.

#### 4.10 Buttercup Leys, Secondary education s106

This s106 funding of £502,800 has been secured as a result of housing development within Derbyshire County Council's administrative boundary and is required to be spent on secondary school provision for Secondary education facilities at Noel Baker Community School including the provision of replacement classrooms. The funding is legally required to be spent on mainstream educational facilities at Noel-Baker Academy, which is the catchment area secondary school for the housing development site. It is not necessary to make any changes to the current admission numbers of the school as part of this proposal.

4.11 Following close partnership working with L.E.A.D Academy Trust, it is proposed to complete a scheme for a two classroom teaching block, with toilet and office provision, at a cost of up to £502,800 at Noel-Baker Academy. The scheme is to be funded from the s106 agreement contribution the City Council has received from the County Council housing development and specified for use at Noel-Baker Academy. Appendix 2 sets out the necessary changes to the capital programme for this scheme. It is proposed to award a standard grant agreement to L.E.A.D Academy Trust as set out in paragraph 7.6. The Trust will then directly progress this project.

#### 4.12 Landau Forte College Derby

Following Cabinet approval of the expansion of Landau Forte College Derby, the Council, Landau Forte Charitable Trust and the DfE have worked in close partnership to secure the necessary DfE consents for the expansion of the College. By April 2022 it is anticipated that the DfE will have approved the expansion of the College, subject to the final terms of the necessary site acquisitions and land transfers being agreed. The initial proposals were for the Council to acquire the sites for the College, before then agreeing terms for the onward transfer to Landau Forte Charitable Trust.

- 4.13 It may be necessary for the Council to acquire the necessary additional sites, as outlined in the confidential Part 2 Cabinet report and approved by Cabinet in November 2021, and then either pass these to Landau Forte Charitable Trust either via a leasehold or via a freehold transfer. Alternatively, it may be necessary for the Council to provide an additional grant to Landau Forte Charitable Trust and for the Trust to acquire the sites directly, subject to paragraph 7.8.
- 4.14 It is therefore necessary to update the delegated authority to the Strategic Director of Corporate Resources, in consultation with the Director of Children's Integrated Commissioning, to complete the site purchases and subsequent disposals / transfer in the format most suitable to secure successful completion of the project in consultation with the DfE. The Council will ensure the terms of the final acquisitions and disposals / transfers provide sufficient security for the provision of the additional school places. If it is necessary to provide an additional grant to Landau Forte Trust, this will be in line with the Council's standard terms and conditions. The final acquisition and disposal / transfer method will only proceed if it can be demonstrated to meet the required programme for the delivery of the school places and be contained within the existing approved budget.

#### Public/stakeholder engagement

5.1 The Council have developed the priority projects set out in this report in conjunction with the schools.

#### Other options

6.1 The available capital funding has been prioritised in line with the School Asset Management Plan to deal with the most urgent condition and health and safety issues.

#### Financial and value for money issues

- 7.1 The Council's school condition maintenance allocation available for 2022/23 is £3,223,906 for Community and Foundation schools. This is made up of a confirmed 2022/2023 allocation of £3,163,425 from the DfE and £60,481 from the balance of previously announced unallocated school condition funding (subject to 2021/22 year-end). The schools Devolved Formula Capital allocation has been confirmed as £302,106. The 2022/23 capital programme budget, approved at February 2022 Cabinet, included indicative budget estimates for School Condition Allocation and Devolved Formula Capital funding, as set out in Appendix 1. The capital programme needs to be updated to reflect the respective confirmed allocations, as set out in Appendix 1.
- 7.2 Appendix 1 outlines funding for the Schools Capital Programme for 2022/23 to be invested across the schools' estate. Appendix 2 outlines the proposed school condition projects.
- 7.3 All School Capital Programme schemes will be procured in line with the Council's Contract Procedure Rules.

- 7.4 The Council has now completed the final s106 agreement with the Snelsmoor Grange, Boulton Moor, housing developer for the provision of a new 1.5 form intake Primary school. Funding of £7,084,154 will be provided to the Council, by the developer, on completion of the proposed school site transfer to the Council. Legal notice for the transfer of the site, and the funding, has now been served by the Council. The funding and the site will be transferred to the Council in June 2022. Updating the Capital programme now represents no risk to the future funding of the capital programme.
- 7.5 For the Council to award the construction contract for the new school following receipt of the site, and to ensure construction work is completed for the proposed September 2023 opening, it is necessary to amend the capital programme with the addition of £7,084,154. This will be applied to the capital programme as set out in appendix 2.
- 7.6 In line with other capital projects delivered at Academy schools, it is proposed that the construction works associated with the proposed project at Noel-Baker Academy will be funded through a standard Council grant agreement with the Trust, as the Trust will be responsible for delivery of this project and undertaking the works directly, working closely with their appointed professional and technical advisors. Therefore, it is proposed to enter into a grant funding agreement with the Trust for the award of up to £502,800. In line with the s106 agreement for Buttercup Leys, the s106 will fund the Council's grant for this project.
- 7.7 The proposed site acquisitions and disposals associated with the expansion of Landau Forte College Derby, and any further grant agreement, if necessary, will be funded from within the budget of the existing approved capital programme scheme. It is not proposed to make any changes to the capital programme budget as a result of the updated delegations, sought here, for the Landau Forte College Derby expansion.
- 7.8 The Council will only be able to increase the grant for Landau Forte Charitable Trust in line with capital programme restrictions which prevent the use of borrowing to fund the awarding of grants. It will only be possible for the Council to increase the grant sum for Landau Forte Charitable Trust to acquire both proposed sites, if necessary, if the Council can first substitute other grant funding to replace any borrowing requirement for the approved Landau Forte College expansion scheme, which will be subject to identifying a suitable funding switch and further approvals.

#### Legal implications

- 8.1 If any works require planning permission approvals, these will be sought prior to works commencing. Where there is an impact on School Playing Fields being able to provide team game playing field pitches, the Council will consult with Sport England.
- 8.2 The Equality Act 2010 places a duty on all schools and Local Authorities to plan to increase over time the accessibility of schools for disabled pupils.

#### **Climate implications**

9.1 All school capital programme schemes will be carried out in line with the latest Building Regulations approved documents on environmental performance. Where possible, schemes will be designed to allow for future improvements to move towards net zero carbon goals subject to future funding availability.

#### Other significant implications

#### 10.1 Equalities Impact

The Council aims to take reasonable steps to remove, alter or provide reasonable means of avoiding physical features that make it impossible or unreasonably difficult for disabled people. Where appropriate, schemes will take account of any accessibility requirements.

#### 10.2 Health and Safety

The priority projects are important for Health and Safety reasons and to conform to Workplace Regulations 1992 and Building Regulations 2010. Health and Safety procedures will be followed in delivering schemes.

#### 10.3 Property and Asset Management

An on-going programme of work is required in school premises to deal with essential condition and health and safety issues to ensure that school buildings remain safe and open.

#### 10.4 Risk Management and Safeguarding

The priority projects will reduce the risk of future school closures due to structural, mechanical or electrical failures. It should be noted that that the overall school condition backlog exceeds the funding available, therefore schemes are prioritised where there is greatest risk of school closure in order to ensure schools remain safe and open. Where it has not been possible to prioritise schemes, mitigation plans will be developed in consultation with schools.

10.5 All projects will be managed and monitored in line with the Council's project management and risk assessment procedures.

#### 10.6 Corporate objectives and priorities for change

This report supports the Council priority outcomes of Enabling individuals and communities, raising achievement and skills, and Making the most of our assets.
