Report of the Office of the Police & Crime Commissioner for Derbyshire (OPCC)

### Public Health Outcomes Framework Detail Report: Violent Crime

### SUMMARY

- 1.1 An overview of current performance across the Public Health Outcomes Framework was presented at the Health and Wellbeing Board held on 16<sup>th</sup> January.
- 1.2 The report showed Derby's performance against each available indicator ranked in relation to the other 152 local authorities. Those indicators where Derby performed amongst the top 20% local authorities and bottom 20% of local authorities was reported.
- 1.3 Further update and detail was requested on the following indicator:
  - Violence Crime (including sexual violence) hospital admissions for violence.
- 1.4 The Office of the Police & Crime Commissioner (OPCC) does not have access to data on hospital admissions and has therefore focussed on levels of violent crime.
- 1.5 Data shows that at Derbyshire, Derby City and Derby CSP are all showing a positive downward trend in all categories.
- 1.6 As with most areas in England and Wales the levels of sexual violence (including rape) reported has seen an increase. The levels of reporting have been affected by the high profile national cases such as Operation YEWTREE and the Jimmy Saville case.

# RECOMMENDATION

- 2.1 To receive and note this report.
- 2.2 That the Board might considering either visiting or looking at the work in either North Tyneside or Sheffield as they are the best performing areas within the CSP Most Similar Group and may have good practice that could be followed in Derby City.
