

## **Private Sector Empty Homes Strategy 2021-2026**

### **Governance Procedure Note**

The corporate strategic aims of the strategy, bringing empty homes into use, is reported through the DORIS reporting system. This is completed quarterly and records the number of empty homes brought into use in the specified Quarter and the cumulative total for the year.

These targets within the Empty Homes Strategy are aligned with the Strategic Housing Business Plan. The number of empty homes brought into use and, of these, the number by use of compulsory purchase powers are reported annually; at the end of each financial year.

Also, at the end of each financial year, further achievements of the Empty Homes Service are reported to the Housing Strategy Manager, for inclusion in the Strategic Housing annual HIT achievements report. In addition to the corporate targets this document highlights additional contributions made. As well as the number of empty homes brought into use, this document also reports the amount of empty homes loans funding committed, the amount of new homes bonus income gained or losses prevented and the amount of empty homes associated debt recovered during the financial year.

Records on the Empty Homes Database and Empty Homes Assistance Loan files and the CTB1 return, compiled by the Revenues and Benefits Manager, are used for the above returns.

The following Action Plan details the plan of work for the Empty Homes Team throughout the lifetime of the Strategy and forms the basis for continued service delivery and investigation of service improvements. This is reported to the Housing Renewal Review Group (Chaired by Head of Service for Strategic Housing) quarterly; where actions will be reviewed and amended by HRRG as necessary, and matters escalated from HRRG to Departmental Management Team and onto Cabinet Member where appropriate.
