# **Outside Bodies Appointments**

## 2.6 Groundwork Derby and Derbyshire Trust Board

Following discussions with a range of interests, including discussions within Derby City Partnership, the City Council agreed to support an extension of the well established Groundwork Erewash Valley Trust. The new Trust relates to the City and other parts of the County and has the title Groundwork Derby and Derbyshire. It was formally launched at a ceremony at Kedleston Hall on 19 October.

Therefore Council is asked to approve the appointment of Councillor Wynn as the council appointed representative on the Groundwork Derby and Derbyshire Trust Board for the remainder of the municipal year.

### 2.7 Cathedral Quarter Business Improvement District Company

Business Improvement Districts – BIDS - are part of the Government's long term strategy of encouraging partnership working, by maintaining the existing level of local authority service provided through business rates whilst allowing additional ringfenced sums to be collected and applied to specific improvements. Improvements are made if the majority of ratepayers approve them in the form of a vote. In this way businesses will have a direct role in deciding what improvements should be made in their local area. There are now 36 BID areas across the UK in cities such as Bristol, Lincoln, London and Ipswich, there are also 7 BID areas which have failed to secure a positive vote, including Chester and Leicester. Derby's proposed area focuses on the northern part of the city with a view to establishing an entity which can be promoted as an area which compliments the Westfield development.

Therefore Council is asked to approve the appointment of Councillor Wynn as the council appointed representative on the Business Improvement District Company for the remainder of the municipal year.
