- values the positive improvement in road safety and reduction in the frequency and numbers killed and seriously injured on roads that reducing the speed limits in residential areas brings.

And therefore asks the Cabinet Member for Planning and Environment to consider introducing into the Highways and Transport work programme, the preliminary work necessary to bring 20mph speed limits on many residential side streets.'

It was proposed by Councillor Holmes and seconded that the motion be amended to read as follows

'Council welcomes recent changes announced by Parliamentary Under Secretary of State for Transport, Norman Baker MP to reduce time consuming and costly bureaucracy for councils wanting to introduce 20mph speed limits.

Council encourages and supports Neighbourhood Boards across the City, to continue to identify their local priorities and consider the implementation of 20mph limits as part of the package of measures available to improve road safety.
