Determination of Admission Arrangements for Community and Voluntary Controlled Schools 2008 - 2009

SUMMARY

- 1.1 The Council has consulted as required on the proposed admission arrangements and relevant area for 2008-2009. - 1.2 Subject to any issues raised at the meeting, I support the following recommendations.

RECOMMENDATIONS

- 2.1 Amend the admission arrangements for 2008 / 2009 as follows:
 - Minor date changes for Primary and Secondary transfer.
 - Published Admission Number for Dale Primary to increase at Key Stage 2 only by 6 to 81.
 - The new Normanton Primary School to have a Published Admission Number of 75.
 - Other Published Admission Numbers have no changes but a proviso regarding Children Centres that may lead to some changes.
- 2.2 To delegate to the Admissions Forum the power to make any minor amendments to these arrangements arising from discussions at the Admissions Forum meeting.

REASON FOR RECOMMENDATIONS

3. To agree the proposed admission arrangements and published admission numbers for 2008-2009 would ensure consistency for parents and compliance with the Code of Practice on School Admissions.

SUPPORTING INFORMATION

- 1.1 The School Standards and Framework Act 1998, as amended by the Education and Inspections Act 2006, requires admission authorities to determine their admission arrangements annually, with certain exceptions, and to consult other local admission authorities in the relevant area before doing so. Our relevant area is the Council's administrative area. The 2006 Act requires the consultation about admissions for September 2008 to be completed before 1 March 2007 and be determined by 15 April 2007.
- 1.2 We have consulted as required on our proposed admission arrangements and relevant area for 2008-2009. The consultation included all schools in Derby, as well as Derbyshire County Council and schools in Derbyshire that border the city. The Admissions Forum for Derby City will meet to approve the arrangements shortly.
- 1.3 Dates given on page 8 of the primary booklet about requesting a place for all Derby City primary schools need to reflect deadline for the co-ordinated scheme of 14 December 2007. The offer date will be the 4 April 2008
- 1.4 Dates given on page 8 of the secondary booklet about requesting a secondary school place need to reflect the deadline for the co-ordinated scheme of 22 October 2008. The national offer date will remain as 1 March 2008, but with this being a Saturday government guideline will be adhered to which state that offers should be posted the next working day.
- 1.5 The Published Admission Numbers carries a proviso that admission limits may need to be reviewed at some schools as part of any Children's Centre proposals linked to the second phase of centres. Until the second phase has been finalised, which may not be in this academic year, these numbers cannot be assessed.
- 1.6 Dale Community Primary School's increase in Key Stage 2 Published Admission Number formalises the historic position of the school taking the overflow of children from St Chad's Church of England (Controlled) Infant School.
